Note:-

1. The constitution of Special Benches at Lucknow Bench dated 22-07-2020 from 27-07-2020 to 31-07-2020 stands modified to the above extent.
2. In view of pandemic of COVID-19, the roster w.e.f. 13-07-2020 shall remain inoperative till further orders.
3. All fresh matters may be filed in e-mode or in physical form, without any urgency application.
4. Only those LISTED matters shall be listed in Courts, for which urgency applications, filed through e-mode are allowed by the Court. Such matters shall be listed only in Additional Cause-List.
5. Urgency applications for hearing of LISTED matters may be filed in physical form and such applications will be placed before Hon'ble Court having jurisdiction over the matter in effective Constitution of Special Benches as on date, provided Urgency/Listing/other likewise applications in the TU/PH matters shall be placed before the TU/PH Bench.
6. The Daily Cause-List shall not be printed/published till further orders.
7. The administrative order dated 16-12-2013 regarding part-heard and tied-up cases will continue in operation.
8. The administrative order dated 15-11-2018 and 20-06-2019 regarding nominated matters will continue in operation.
9. All cases where the vires of Central or State Legislation is challenged be listed before the appropriate Division Bench having jurisdiction over the matter falling under the legislation in issue.
