Note:

1. The Constitution of Special Benches dated 09.09.2020 and Supplementary Constitution of Special Benches dated 10.09.2020 w.e.f. 14th to 18th September 2020 **now stands withdrawn** due to rapid surge of COVID-19 cases in Prayagraj.
2. In view of pandemic of COVID-19, **the roster w.e.f. 13.07.2020 shall remain inoperative** till further orders.
3. Only those **LISTED** matters shall be listed in Hon'ble Courts, for which urgency applications are allowed by the Hon'ble Courts. Such matters shall be listed only in Additional Cause List.
4. Urgency applications shall be placed before the Bench having jurisdiction over the matter, provided urgency applications in TU/PH matters shall be placed before the TU/PH Bench.
5. The Daily Cause List shall not be printed/published till further orders.
6. All cases where the vires of Central or State Legislation is challenged be listed before the appropriate Division Bench having jurisdiction over the matter falling under the legislation in issue.
7. The High Court shall function in accordance with the Modalities and Arrangement dated 24.07.2020 for functioning of High Court during COVID-19.
