#### Instructions

- 1. The Registrar General on behalf of High Court Allahabad invites the sealed tender from the interested firms for sale of old computers, printers, UPS and related equipments lying in the Computer Centre, High Court, Allahabad.
- 2. Tender once submitted cannot be withdrawn.
- 3. Bidders are required to submit tenders for the items mentioned in **Table-[A]**. Bids submitted for part of the items shall not be considered.
- 4. The interested firms may submit their sealed tender in attached proforma along with **Earnest Money Deposit (E.M.D.) of Rs.10,000/-** through Demand Draft in favour of Registrar General, High Court, Allahabad). Any bid not accompanied by an acceptable Earnest Money, shall be rejected.
- 5. Sealed Tenders addressed to Registrar General, High Court, Allahabad in attached proforma must reach *Computer Centre*, *High Court*, *Allahabad* latest by 27th July, 2013 upto 2.30 p.m. Any tender received by the Computer Centre after the deadline prescribed in tender document will be returned unopened to the firm.
- 6. Quantity/items fixed for selling as mentioned in Table-[A] may change as per discretion of Hon'ble High Court.
- 7. Before the deadline for submission of tender, the High Court may modify the tender documents by issuing addenda. Any addendum thus issued shall be part of the tender documents and same shall be published in the official web-site of the Court.
- 8. Each page of the tender shall be typed or written in indelible ink and shall be signed by the representative duly authorized to sign on behalf of the firm.
- 9. The tender shall contain no overwriting, alterations or additions, except those to comply with instructions issued by the High Court.
- 10. The Earnest Money of unsuccessful tenderers will be returned at the earliest after the finalization of successful firm.
- 11. The Earnest Money of the successful firm will be either adjusted against the overall tender amount or returned after firm deposits the full amount.
- 12. The tenders received will be opened in the presence of the firms/representatives who choose to attend at the time, date and place specified in the tender document.
- 13. The High Court will award the Contract to the firm whose tender has been determined to be substantially responsive to the tender documents and who has offered the highest tender price for the purchase of items.
- 14. Notwithstanding the above Clause, the High Court reserves the right to accept or reject any tender, to extend the date of submission & opening if sufficient no. of bids are not received, to cancel the tender process or to reject all tenders.
- 15. The firm whose tender has been accepted will be informed by letter. The bidder has to deposit this requisite amount within the period of 7 days after the receipt of letter of acceptance thereafter firm will be allowed to take away the items deemed sold.
- 16. Short-listed successful bidder shall deposit requisite amount within 7 days from the date of receipt of acceptance letter failing which the High court shall cancel the tender and forfeit the Earnest money deposited.
