**Instruction:** All the applicants shall submit their applications (on proforma annexed herewith) containing self-attested xerox copies of the documents of the particulars mentioned in the application along with the photocopies of character roll entries of last 5 years to the District Judge concerned , who shall after making proper scrutiny forward the same to the Hon'ble Court along with his remarks without any delay for consideration of the Hon'ble Court.
