## Instructions

Qualification: A person shall not be qualified for appointment as a Special Judicial Magistrate unless he/she:-

holds or has held any post under the Government;

possesses the degree of law or otherwise is well experienced in relation to (b) legal affairs to the satisfaction of the High Court.

The term of the office as Special Judicial Magistrate/Special Term of Office: Metropolitan Magistrate shall be four years from the date of assumption of his charge or attaining the age of 70 years whichever is earlier.

Documents required with application: All the applicants shall submit their applications containing self-attested xerox copies of the documents of the particulars mentioned in the application alongwith the photocopies of character roll entries of the last 5 years of their Government Job.

Submission of Form: All the applicants shall submit their applications alongwith all the relevant documents to the District Court(s) of the district(s) for which they are applying for the post of SJM/SMM. The District Judge(s) after proper scrutiny shall only forward those applications to the High Court which he finds fit for the post of SJM/SMM alongwith his remarks without any delay.

By the order of the Court
