#### **Instructions / Terms & Conditions**

- 1. The Registrar General on behalf of High Court Allahabad invites the sealed tender from the interested firms for supply and installation of 17 nos. UPS (800 VA) with 3 years onsite comprehensive warranty for use in High Court, Allahabad and its Bench at Lucknow.
- 2. Tender once submitted cannot be withdrawn.
- 3. Sealed Tenders addressed to Registrar General, High Court, Allahabad in attached proforma must reach Computer Centre, High Court, Allahabad latest by 6<sup>th</sup> March 2023 upto 2.30 p.m. Any tender received by the Computer Centre after the deadline prescribed in tender document will be returned unopened to the firm.
- 4. **Tender Validity Period** Quoted rates should be valid for 120 days from the date of opening of tender.
- 5. **Scope of Supply** (Tender price to include all cost components): Supply, installation, testing and Commissioning of Goods.
- 6. The interested firms may submit their sealed tender in attached proforma along with Earnest Money Deposit (E.M.D.) of Rs. 2,230.00 through Demand Draft payable at Allahabad. A Bid received without Earnest Money or with Earnest Money of lesser value will be out rightly rejected. Earnest Money shall remain valid for a period of 45 days beyond the Tender Validity Period.
- 7. Earnest money and Performance Bank Guarantee should be in favour of 'Registrar General, High Court, Allahabad'.
- 8. The successful Tenderer shall have to furnish a Performance Bank Guarantee (PBG) amounting to 5% of total value of the Purchase Order valid for a period of 38 months within 7 days of issuance of Purchase Order by the Hon'ble Court.
- 9. Quantity fixed for purchase may change as per discretion of Hon'ble High Court.
- 10. Before the deadline for submission of tender, the High Court may modify the tender documents by issuing addenda. Any addendum thus issued shall be part of the tender documents and same shall be published in the official web-site of the Court.
- 11. Each page of the tender document shall be typed or written in indelible ink and shall be signed by the representative duly authorized to sign on behalf of the firm.
- 12. The tender shall contain no overwriting, alterations or additions, except those to comply with instructions issued by the High Court.
- 13. The Earnest Money of unsuccessful tenderer will be returned at the earliest after the finalization of the tender.
- 14. The tenders received will be opened in the presence of the firms/representatives who choose to attend at the time, date and place specified in the tender document.
- 15. **Tender Evaluation Method** Total value wise evaluation.

- 16. The High Court will award the Purchase Order to the firm whose tender has been determined to be substantially responsive to the tender document and who has offered the lowest tender price for the supply of items subject to quality.
- 17. Notwithstanding the above clause, the High Court reserves the right to accept or reject any tender, to extend the date of submission & opening if sufficient no. of bids are not received, to cancel the entire tender process or to reject all tenders.
- 18. The firm whose tender has been accepted will be informed by letter.
- 19. All applicable taxes, if any at admissible rate, has to be paid by the successful tenderer.
- 20. Maintenance Service procedure must be mentioned in the tender document.
- 21. Tender items will be used by Hon'ble Judges of the High Court thus only well reputed brands having top international rating in performance and service during the whole warranty period, will be acceptable. Tenderer should quote product of top international reputed brands only, any inferior brand will not be acceptable. Buyer reserves the right to select or reject the Tender due to its brand.
- 22. Buyer reserves the rights to terminate the Tender without assigning any reason thereof at any stage.
- 23. Buyer has the sole right to set aside any Terms and Conditions for all the Tenderer during Technical Evaluation of the Tender.
- 24. The quantity of the goods (Hardware / Software) may increase / decrease as per the requirement of the buyer. Further, the repeat order(s) may be issued to the tenderer to supply the same product with same rate within one year.
- 25. Force Majeure Clause If at any time during the continuance of the Contract, the performance in whole or in part by either party of any obligation under this Contract shall be prevented or delayed by the reasons of any war, hostility, acts of the public enemy, epidemics, civil commotion, sabotage, fires, floods, explosion, quarantine restrictions, strikes, lockouts or act of God provided notice of happening of such event duly evidenced with documents is given by one party to the other within 21 days from the date of occurrence thereof, neither party shall be by reasons of such event, be entitled to terminate the Contract nor shall either party have any claim for damages against the other in respect of such non-performance or the delay in performance, and deliveries under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist, and the decision of the Buyer as to whether the deliveries have been so resumed or not, shall be final and conclusive, Provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days, either party may at its option terminate the contract provided also that the Buyer shall be at liberty to take over from the Seller at a price to be fixed by Buyer, which shall be final, all unused, undamaged and accepted material, bought out components and Goods in course of manufacture in the possession of the Seller at the time of such termination or such portion thereof as the Buyer may deem fit excepting such materials, bought out components and Goods as the Seller may with the concurrence of the Buyer elect to retain.
- 26. Delivery, Installation, Warranty, Complaint Redressal and Penalty
- a) The delivery of goods of present tender shall be made strictly **within 21 days** from the issuance of the Purchase Order.

- b) If the Seller fails to deliver any or all of the goods within the original/re-fixed delivery period(s) specified in the Tender, the Buyer will be entitled to deduct / recover the Penalty for the delay, unless covered under aforesaid Force Majeure conditions.
- c) The goods shall be delivered free on board at premises of the Purchaser / Consignee in good condition on working days during office hours.
- d) The Purchaser/Buyer shall have right to inspect the goods at the time of delivery by itself or by any agency nominated by it. The tenderer shall extend all facilities for the inspection / testing of the goods at the premises of either at buyer or tenderer / OEM at the discretion of the purchaser. If it is found that the delivery is not as per terms of the Purchase Order, the purchaser may refuse to take delivery of the same and shall be at liberty to take action as per the agreement / contract / purchase order.
- e) In case of delayed delivery of goods except for Force Majeure cases, the Seller shall be penalised by the Buyer for every week of delay, penalty amounting to 2% of the total value of the items whose delivery has been delayed. Any fractional part of a week is to be considered a full week. Fractional delivery of any item will be considered as non delivery and will be penalised accordingly. In case, delay in delivery is beyond four weeks, the Purchase Order may be canceled and penalty amounting to 50% of Performance Bank Guarantee (PBG) value will be levied at the discretion of Purchaser.
- f) In the event of failure to supply whole or part of the Purchase Order items as per terms and conditions, the Performance Bank Guarantee or Earnest Money so deposited by the tenderer shall be forfeited and other legal action may also be initiated. Further, the tenderer may be blacklisted from participating in the further tender(s) of the High Court for 5 years.
- g) All penalties shall be recovered from any current / running bills of the tenderer or by Performance Bank Guarantee (PBG). Penalty shall be deducted with applicable taxes.
- h) The warranty period shall commence post delivery; Installation, Testing and Commissioning of goods at Consignee location.
- i) Post Delivery Installation, Testing and Commissioning of items supplied shall be completed by the tenderer within 3 days from the date of supply at consignee location. In case of delay in installation, testing and commissioning, a penalty at the rate of 1% per week of the total value of order or the actual cost of billing or part thereof, as the case may be, shall be imposed by the purchaser at its discretion and shall be recovered from payment due to the tenderer including Performance Bank Guarantee furnished.
- j) Post installation Onsite support needs to be provided by the successful tenderer / OEM for entire warranty period. Tenderer / OEM shall provide priority service and provide an exclusive Telephone / Mobile number and email id to monitor the complaints registered by the Hon'ble High Court, Allahabad against all the supplied items. The successful tenderer will have to provide contact numbers of service engineers for both at Allahabad and Lucknow.

- k) The service engineer will required to visit the premises of the High Court Allahabad and its bench at Lucknow or at any other site communicated to the tenderer to diagnose the issue and take immediate actions to get the issue resolved. It will be the sole responsibility of the tenderer / OEM that he will take all the necessary actions to attend the complain with maximum response time of 24 hours and will log the complain with the OEM, if required. Any delay in service engineer visiting the communicated site within 24 hours (excluding the gazetted holidays and Sundays) will entitle the High Court/Buyer to penalise the tenderer / OEM at the rate of Rs. 50/per item per day for UPS (800 VA).
- I) Complaints needing replacement of spare parts shall be resolved within 3 business days. If any complaint requiring parts replacement is pending for more than 3 business days, it will entitle High Court/Buyer to penalize the tenderer / OEM for delay at the rate of Rs. 50/- per item per day for UPS (800 VA), from the date of complain being first reported to the tenderer / OEM.
- m) Any delay in replacement of spare part or dilly dallying for replacing the spare part during entire warranty period, by providing ambiguous software solutions viz. resolving the issue through software updates etc. and if the same problem re-occurred with 3 days from the date of resolution of earlier complaint reported to the tenderer / OEM, will entitle High Court / Buyer to penalize the tenderer / OEM at the rate of Rs. 100/- per item per day for UPS (800 VA).
- n) Tenderer / OEM will have to send a service engineer to the communicated site on the same day of the receipt of complaint through telephone / mobile number / email id. Tenderer must provide dedicated telephone / mobile number and email id, the same must be monitored by the competent person at tenderer end. No leniency with regard to calls going unreceived or emails being unread shall be accepted and penalty for delay in providing service will be enforced as mentioned above.
- o) In the event of failure to supply whole or part of the Purchase Order items as per terms and conditions, the Performance Bank Guarantee or Earnest Money so deposited by the tenderer shall be forfeited and other legal action may also be initiated. Further, the tenderer may be blacklisted from participating in the further tender(s) of the High Court for 5 years.
