All the taxes should be included in the tender rates with the brand names and after submitting the tender, increase of rate and taxes will NOT be admissible. A **demand Draft of Rs. 10,000/-, in the favour of District Judge, Pilibhit** must be enclosed with the tender. Sample of papers must be enclosed with tenders, bearing with stamp & sign of proprietor of concerned firm.

List of the required Stationary items is on separate sheet & may be obtained from website/Office of Nazarat /Notice Board. The information regarding repair work mentioned in the attached list can be obtained on any working day from the Computer Section of District Court, Pilibhit.

The interested Firms must submit their Tenders latest by **March 18 2017 up to 2:00 pm** Positively and the above tenders will open at **4:00 pm** in the presence of purchase committee, District Court Pilibhit at the Nazarat office, Civil Court Pilibhit.

The discretion to reject any/all tenders without assigning any reason will lie with the District Judge Pilibhit and his decision will be final.

The selected firm must supply the stationary items and repair of computer equipments (as shown in enclosed list) at their own cost/ expenses within the period of 7 days after receiving the supply order.

In case of any dispute matter will be consider under jurisdiction of Pilibhit Judgeship.
