

## **District Court Saharanpur**

### **Tender Notice**

Sealed tenders are invited for supply and installation of fire extinguishers in District Court Saharanpur & Outlying Court Deoband, Saharanpur.

### **Terms & Conditions of Tender**

1. The Number and type of fire extinguishers is given in Table A.
2. The Tenderer shall produce the samples of fire extinguishers at the time of finalizing of Tender Process. Tenders not supported by the samples will not be considered.
3. The Tenderer must be having a local sales and maintenance service support office since last three years at Saharanpur.
4. The Tenderer may obtain the Tender Document along with Terms & Conditions from the Nazarat Section of District Court Saharanpur on any working day between 10.00AM to 5.00PM.
5. The Tenderer shall deposit the Earnest Money of Rs. 10,000/- in the form of a Fixed Deposit of a Nationalized Bank /BankDraft / Banker's Cheque payable at Saharanpur in favour of the District Judge, Saharanpur. The Earnest Money deposited by the unsuccessful tenderer shall be returned after finalization of Tender Process. For the successful tenderer the Earnest Money will be returned after depositing the Security Money of Rs. 20,000/- by the successful tenderer.
6. The Security Money of Rs. 20,000/- will be taken as a bank Demand Draft payable at Saharanpur in favour of the District Judge, Saharanpur, which will be returnable, after satisfactory supply and installation of fire extinguishers.
7. The Firm shall charge the rates as accepted at the time of finalization of Tender Process for each item. Rates once approved shall not be enhanced.
8. The Firm approved shall supply and install the requisite items within a period of seven days from the date of written Order. In case of any failure in this regard, the District Court shall have a right to deduct reasonable amount from Security Money as penalty.
9. The Firm shall bear the entire cost of conveyance and installing the Fire Extinguishers and shall also ensure that the Fire Extinguishers remain fit for use for the period of 3 years from the date of installation.
10. The Firm shall guarantee that items, supplied to the District Court under this tender, shall be of the best quality as per specification and new (i.e. fresh stock) in all respect, along with three years of guarantee. The firm will demonstrate and train the staff to operate the Fire Extinguishers along with precautions and necessary action which should be kept in mind by District Court staff.



11. The firm shall ensure that at the place of installation of Fire Extinguishers operating instructions along with do's and don'ts be displayed both in Hindi and English in affixed laminated form or in the form of notice board.
12. If any item supplied by the firms is not found up-to the mark and not in accordance with the approved samples, the items will not be accepted and the supplier shall be liable to pay 5% of cost as damages of the particular work order.
13. In case firm fails to execute the said work/supply within the stipulated time, District Court will be at liberty to get the material/items from the open market, without any notice to the firm and any additional cost incurred by District Court for the same shall be recovered from the firm.
14. The rates should be quoted including all charges and taxes and installation cost, nothing extra shall be paid.
15. The District Court reserves the right to reject any tender without assigning any reason.
16. The copy of PAN Card of tenderer, Trade Tax/GST Registration should be enclosed.
17. The District Court may at any time terminate the Contract by giving written notice to the Successful tenderer, without compensation to the Successful Tenderer if the Successful Tenderer becomes bankrupt or otherwise insolvent as declared by the competent Court.
18. The tenders received will be opened in the presence of the firms/representatives who choose to attend at the time, date and place specified in the tender document.
19. The District Court will award the Contract to the firm whose tender has been determined to be substantially responsive to the tender documents and who has offered the lowest tender price for the supply of items subject to quality.
20. Notwithstanding the above Clause, the District Court reserves the right to accept or reject any tender, to extend the date of submission & opening if sufficient no. of bids are not received, to cancel the tender process or to reject all tenders.
21. Quoted rates must be valid for financial year 2018-2019.
22. The Tenders will be opened on 16.03.2019 at 4.30 P.M in Nazarat Section, District Court Saharanpur.
