In pursuance of the advertisement No. A.R.O. & R.G.C./ 01/ 2014 dated 31.07.2014 High Court of Judicature at Allahabad, 287 candidates were declared successful in the Assistant Review Officer Examination, 2014 and were offered to accept and join the post within the time limit, as prescribed in the letter dated 28.07.2015.
