3- महानिबन्धक, मा0 उच्च न्यायालय, इलाहाबाद के अर्द्धशासकीय पत्र संख्या-170 एस एण्ड ए/2019, दिनांक 28-03-2019 के माध्यम से उपलब्ध करायी गयी संस्तुति में उ0प्र0 उच्चतर न्यायिक सेवा के अभ्यर्थी/न्यायिक अधिकारियों में से क्रमांक-54 पर अंकित अभ्यर्थी सुश्री पूनम सिंघल का चरित्र एव पूर्ववृत्त सत्यापन प्राप्त न होने के कारण इनकी नियुक्ति के सम्बन्ध में पृथक से आदेश निर्गत किये जायेंगे।

4- उपर्युक्त अभ्यर्थी की ज्येष्ठता अनितम मानी जायेगी तथा ज्येष्ठता सूची मा0 सर्वोच्च न्यायालय एवं मा0 उच्च न्यायालय द्वारा समय-समय पर पारित विधिक व्यवस्थाओं के आधार पर मा0 उच्च न्यायालय द्वारा निर्धारित की जायेगी।

- 5- उपर्युक्त नियुक्ति मा0 सर्वोच्च न्यायालय/मा0 उच्च न्यायालय में योजित सम्बन्धित अन्य रिट याचिकाओं में पारित होने वाले अन्तिम निर्णय के अधीन होंगी। ऐसे समस्त न्यायिक अधिकारियों की नियुक्ति सतर्कता जांच के निष्कर्ष के अधीन होगी, जिनके विरूद्ध सतर्कता जांच लम्बित है।
- 6- सीधी भर्ती के माध्यम से चयनित होने वाले अभ्यर्थियों के पूर्ववृत्त एवं चिरत्र के सम्बन्ध में उ0प्र0 उच्चतर न्यायिक सेवा में कार्यभार ग्रहण किये जाने से पूर्व की अविध का कोई प्रतिकूल तथ्य यदि अभ्यर्थी के स्वयं के संज्ञान में नहीं है तो इस आशय के शपथ-पत्र के साथ महानिबन्धक, मां0 उच्च न्यायालय, इलाहाबाद के आदेशों के अनुसार वे यथानिर्दिष्ट स्थान पर कार्यभार ग्रहण करने हेतु उपस्थित होंगे। प्रश्नगत अविध में उनके विरुद्ध यदि कोई प्रतिकूल तथ्य उनके संज्ञान में है तो इसकी सूचना वे महानिबन्धक, मां0 उच्च न्यायालय, इलाहाबाद एवं नियुक्ति विभाग, उ0प्र0 शासन, लखनऊ को यथाशीघ्र उपलब्ध करा देंगे।
