Applications are invited from all eligible candidates for the post of "Nyaya Mitra" in the Agra and Allahabad Districts, carrying a fixed honorarium of Rs. 40000/- per month with no Dearness Allowance and/or any other allowances and also without any other perquisite such as residential accommodation etc.

Number of vacancies: 02 (1 each for Agra and Allahabad)

General terms and conditions

- He/she shall be Retired Judicial Officer.
- Preference to candidate who has worked in the same court before retirement.
- Nyaya Mitra will be paid honorarium of Rs. 40,000/- per month.
- Maximum age limit will be 68 years.
- Place of posting will be District Court.
- Extension will be given based on the performance feedback submitted by the respective District Judges.

Term of Office: The term of the office as Nyaya Mitra shall be for a period of 06 months and thereafter their services will be extended for every 06 months with maximum for 02 years from the date of assumption of his charge or attaining the age of 68 years whichever is earlier.

Roles and responsibilities of Nyaya Mitras

- To identify and setting of targets of cases pending over 15 years in respective court.

- To assist in conducting critical analysis of pending cases that may help district judges to understand the issues/bottlenecks and discuss solutions with other government departments and subordinate judiciary for early disposal of old pending cases.
- To coordinate with district authorities for enabling witnesses to come on time or fixed/stipulated time frame for disposal of cases and inform concerned parties.
- To identify the cases in Pre-Lok adalats to be referred to the Lok adalats on priority basis.
- To take necessary action pursuant to orders passed by the district court in relation of old pending cases i.e. issue notice/summons, stay/injunction, order copy, inform the arbitrator, local government departments and issue letters to lower courts for summoning the record etc.
- Support in implementation of other A2J Schemes in District Courts and submit best practices / success stories.
- Any other activities related to disposal of old pending cases.
