In modification of earlier order dated 12.05.2022, Hon'ble Mr. Justice Ajay Bhanot (Court No.68) in addition to his own determination, will take up the fresh cases from serial Nos. 1 to 29 of Court No.77 (Hon'ble Mr. Justice Om Prakash Tripathi) and will also take up the the fresh cases from serial Nos. 1 to 37 of Court No.90 (Hon'ble Mr. Justice Vikas Kunvar Srivastav).
