

ARRANGEMENT

1. The Division Bench presided over by Hon'ble Dr. Justice K. J. Thaker (Court No.2) in addition to its own determination, will take up the determination of Court No.39 (The Division Bench presided over by Hon'ble Mr. Justice Attau Rahman Masoodi).
2. Hon'ble Mr. Justice Attau Rahman Masoodi will sit singly in Court No.39 and will take up the determination of Court No.10 (Hon'ble Mr. Justice Rohit Ranjan Agarwal).
3. In modification of earlier order dated 12.05.2022, Hon'ble Mr. Justice Ajay Bhanot (Court No.68) in addition to his own determination, will take up the fresh cases from serial Nos. 1 to 29 of Court No.77 (Hon'ble Mr. Justice Om Prakash Tripathi) and will also take up the the fresh cases from serial Nos. 1 to 37 of Court No.90 (Hon'ble Mr. Justice Vikas Kunvar Srivastav).

In modification of earlier order dated 12.05.2022, Hon'ble Mr. Justice Saurabh Lavania (Court No.78) in addition to his own determination, will take up the fresh cases from serial Nos. 30 to 58 of Court No.77 (Hon'ble Mr. Justice Om Prakash Tripathi) and will also take up the the fresh cases from serial Nos. 38 to 75 of Court No.90 (Hon'ble Mr. Justice Vikas Kunvar Srivastav).
5. In modification of earlier order dated 12.05.2022, Hon'ble Mr. Justice Vivek Varma (Court No.74) in addition to his own determination, will take up the fresh cases from serial Nos. 59 to 87 of Court No.77 (Hon'ble Mr. Justice Om Prakash Tripathi) and will also take up the Additional Cause List cases from serial Nos. 301 to 344, Applications and remaining determination of Court No.90 (Hon'ble Mr. Justice Vikas Kunvar Srivastav).
6. In modification of earlier order dated 12.05.2022, Hon'ble Mr. Justice Chandra Kumar Rai (Court No.75) in addition to his own determination, will take up the Additional Cause List cases from serial Nos. 322 to 350, Applications and remaining determination of Court No.77 (Hon'ble Mr. Justice Om Prakash Tripathi) and will also take up the fresh cases from serial Nos. 88 to 95 and the Additional Cause List cases from serial Nos. 301 to 321 of Court No.77 (Hon'ble Mr. Justice Om Prakash Tripathi), which were earlier to be taken up by Hon'ble Mr. Justice Vikas Kunvar Srivastav.
