

## **ARRANGEMENT**

1. The Division Bench presided over by Hon'ble Mr. Justice Anjani Kumar Mishra (Court No.46) in addition to its own determination, will take up the fresh cases and remaining determination (except Additional Cause List/Unlisted cases and Applications) of Court No.44 (The Division Bench presided over by Hon'ble Dr. Justice K. J. Thaker).
2. In modification of earlier order dated 09.08.2022, Hon'ble Dr. Justice K. J. Thaker will sit singly in Court No.44 upto midday recess and will take up the determination of Court No.92 (Hon'ble Mrs. Justice Sadhna Rani (Thakur)).
3. In modification of earlier order dated 09.08.2022, Hon'ble Mr. Justice J. J. Munir will sit singly in Court No.6 at 10.00 A.M. till the formation of Division Bench in C.J.'s Court and will also sit singly in Court No.6 after mid day recess and in addition to his own determination, will take up the Additional Cause List/Unlisted cases from serial nos.3001 to 3046 of Court No.37 (Hon'ble Mr. Justice Manish Mathur).
4. Hon'ble Mr. Justice Brij Raj Singh (Court No.82) in addition to his own determination, will take up the fresh cases from serial nos.1 to 44 of Court No.93 (Hon'ble Mr. Justice S. A. H. Rizvi).
5. Hon'ble Mr. Justice Shree Prakash Singh (Court No.86) in addition to his own determination, will take up the Additional Cause List/Unlisted cases from serial nos.3001 to 3050 of Court No.93 (Hon'ble Mr. Justice S. A. H. Rizvi).
6. Hon'ble Mr. Justice Om Prakash Tripathi (Court No.87) in addition to his own determination, will take up the Additional Cause List/Unlisted cases from serial nos.3051 to 3102, Applications and remaining determination of Court No.93 (Hon'ble Mr. Justice S. A. H. Rizvi).
7. In modification of earlier order dated 09.08.2022, Hon'ble Mr. Justice Vikram D Chauhan (Court No.90) in addition to his own determination, will take up the fresh cases from serial nos.1 to 70 of Court No.74 (Hon'ble Mr. Justice Suresh Kumar Gupta) and will also take up the Additional Cause List/Unlisted cases from serial nos.3001 to 3050, Applications and remaining determination of Court No.74 (Hon'ble Mr. Justice Suresh Kumar Gupta), which were earlier to be taken up by Hon'ble Mr. Justice S. A. H. Rizvi (Court No.93).
