

## **ARRANGEMENT**

1. In modification of earlier order dated 31.01.2023, The Division Bench presided over by Hon'ble Mr. Justice Arvind Kumar Mishra-I (Court no.48) in addition to its own determination, will take up the fresh cases from serial nos.1 to 5, Applications and remaining determination (except the Additional/Unlisted cases from serial nos.3001 to 3079) of Court No.44 (The Division Bench presided over by Hon'ble Dr. Justice K. J. Thaker) which were earlier transferred to Court No.45 (The Division Bench presided over by Hon'ble Mr. Justice Pritinker Diwaker).
2. Hon'ble Mr. Justice Dinesh Kumar Singh (Court No.87) in addition to his own determination, will take up the fresh cases from serial nos.1 to 15 and the Additional/Unlisted cases from serial nos.3001 to 3072 of Court No.70 (Hon'ble Mr. Justice Sanjay Kumar Pachori).
3. Hon'ble Mrs. Justice Manju Rani Chauhan (Court No.77) in addition to her own determination, will take up the Additional/Unlisted cases from serial nos.3073 to 3145, Applications and remaining determination of Court No.70 (Hon'ble Mr. Justice Sanjay Kumar Pachori).
4. In modification of earlier order dated 31.01.2023, Hon'ble Mr. Justice Nalin Kumar Srivastava will sit singly in Court No.92 at 10.00 A.M. and in addition to his own determination Court No.92 (Hon'ble Mr. Justice Nalin Kumar Srivastava), will take up the fresh cases from serial nos.1 to 11, Applications and remaining determination (except the Additional/Unlisted cases from serial nos.3001 to 3042) of Court No.6 (Hon'ble Mr. Justice J. J. Munir) and will also take up the fresh cases from serial nos.101 to 195 of Court No.75 (Hon'ble Mr. Justice Vivek Varma).

3. The Additional/Unlisted cases from serial nos.3001 to 3042 of Court No.6 (Hon'ble Mr. Justice J. J. Munir) shall be rotated for 08.02.2023.
