

ARRANGEMENT

1. The Division Bench comprising Hon'ble Mr. Justice Suneet Kumar and Hon'ble Mr. Justice Shiv Shanker Prasad will sit in Court No.42 upto midday recess and again after re-formation of the Division Bench to take up the determination to be taken up there. Hon'ble Mr. Justice Shiv Shanker Prasad will sit singly in Court No.73 after midday recess till the re-formation of Division Bench in Court No.42 and will take up his own determination of Court No.73 (Hon'ble Mr. Justice Shiv Shanker Prasad).
2. Hon'ble Mr. Justice Rajiv Gupta (Court No.49) in addition to his own determination, will take up the determination of Court No.86 (Hon'ble Mr. Justice Vivek Kumar Singh).
3. Hon'ble Mr. Justice S. S. Shamsbery (Court No.76) in addition to his own determination, will take up the determination of Court No.79 (Hon'ble Mr. Justice Krishan Pahal).
4. Hon'ble Mr. Justice Raj Beer Singh (Court No.77) in addition to his own determination, will take up the determination of Court No.81 (Hon'ble Mr. Justice Mayank Kumar Jain).
5. Hon'ble Mr. Justice Chandra Kumar Rai (Court No.18) in addition to his own determination, will take up the fresh cases from serial nos.1 to 56, Applications and remaining determination (except the Additional/Unlisted cases from serial nos.3001 to 3100) of Court No.36 (Hon'ble Mr. Justice Ashutosh Srivastava).
6. In modification of earlier order dated 29.03.2023, Hon'ble Mr. Justice Nalin Kumar Srivastava (Court No.84) in addition to his own determination, will take up the determination of Court No.83 (Hon'ble Mrs. Justice Jyotsna Sharma), which was earlier transferred to Court No.79 (Hon'ble Mr. Justice Krishan Pahal).
7. Hon'ble Mr. Justice Kshitij Shailendra (Court No.52) in addition to his own determination, will take up the fresh cases from serial nos.1 to 9, Applications and remaining determination (except the Additional/Unlisted cases from serial nos.3001 to 3067) of Court No.4 (Hon'ble Mr. Justice Jayant Banerji).

1. The Additional/Unlisted cases of Court No.4 (Hon'ble Mr. Justice Jayant Banerji) shall be rotated as:- serial nos.3001 to 3033 for 06.04.2023 and serial nos.3034 to 3067 for 07.04.2023 respectively.
 2. The Additional/Unlisted cases of Court No.36 (Hon'ble Mr. Justice Ashutosh Srivastava) shall be rotated as:-serial nos.3001 to 3033 for 06.04.2023, serial nos.3034 to 3066 for 07.04.2023 and serial nos.3067 to 3100 for 10.04.2023 respectively.
 3. The matters transferred or assigned in this order are except TU/PH.
