

## **ARRANGEMENT**

1. The Division Bench comprising Hon'ble Mr. Justice M. C. Tripathi and Hon'ble Mr. Justice Surendra Singh-I will sit in Court No.40 to take up the remaining determination to be taken up there. Thereafter, Hon'ble Mr. Justice Surendra Singh-I will sit singly in Court No.47 and will take up the fresh cases from serial nos.94 to 143 of Court No.79 (Hon'ble Mr. Justice Vipin Chandra Dixit), on 22.08.2023.

J. Thaker), on 22.08.2023.
5. Hon'ble Mr. Justice Manoj Bajaj will sit singly in Court No.75 after the Regular Division Bench work in Court No.3 and will take up the fresh cases from serial nos.76 to 135 of Court No.77 (Hon'ble Mrs. Justice Renu Agarwal), on 22.08.2023.
6. Hon'ble Mr. Justice Umesh Chandra Sharma will sit singly in Court No.81 at 10.00 A.M. and in addition to his own determination, will take up the fresh cases from serial nos.109 to 168 of Court No.50 (Hon'ble Mr. Justice Ram Manohar Narayan Mishra), on 22.08.2023.
