

ARRANGEMENT

5. Hon'ble Mr. Justice Piyush Agrawal (Court No.5) in addition to his own determination, will take up the fresh cases from serial nos.103 to 132 of Court No.88 (Hon'ble Mr. Justice Sanjay Kumar Singh), on 28.08.2023.
6. Hon'ble Mr. Justice Vikas Budhwar (Court No.35) in addition to his own determination, will take up the fresh cases from serial nos.161 to 185 of Court No.91 (Hon'ble Mr. Justice Gajendra Kumar), on 28.08.2023.
7. Hon'ble Mr. Justice Umesh Chandra Sharma (Court No.81) in addition to his Single Bench determination at 2.00 P.M., will take up the fresh cases from serial nos.242 to 291 of Court No.79 (Hon'ble Mr. Justice Vipin Chandra Dixit), on 28.08.2023.
