

## **ARRANGEMENT**

4. Hon'ble Mr. Justice Saral Srivastava (Court No.2) in addition to his own determination, will take up the fresh cases from serial nos.154 to 233 of Court No.1 (Hon'ble Mr. Justice Jayant Banerji), on 30.10.2023.
5. Hon'ble Mr. Justice Piyush Agrawal (Court No.5) in addition to his own determination, will take up the fresh cases from serial nos.1 to 82, Applications and remaining determination (except the Additional/Unlisted cases) of Court No.36 (Hon'ble Mr. Justice Manjive Shukla), on 30.10.2023.
6. Hon'ble Mr. Justice Rajendra Kumar-IV will sit in Chamber, on 30.10.2023.
7. Hon'ble Mr. Justice Saurabh Srivastava (Court No.52) in addition to his own determination, is assigned the fresh cases from serial nos.79 to 128 of Court No.51 (Hon'ble Mr. Justice Chandra Kumar Rai), on 30.10.2023.
8. Hon'ble Mr. Justice Manish Kumar Nigam (Court No.47) in addition to his own determination, will take up the fresh cases from serial nos.129 to 158 of Court No.51 (Hon'ble Mr. Justice Chandra Kumar Rai), on 30.10.2023.
