

ARRANGEMENT

2. 8. Hon'ble Dr. Justice Gautam Chowdhary (Court No.68) in addition to his own determination, will take up the fresh cases from serial nos.1 to 31 of Court No.70 (Hon'ble Mr. Justice Sameer Jain).
9. In modification of earlier order dated 09.11.2023, Hon'ble Mr. Justice Dinesh Pathak (Court No.90) in addition to his own determination, is assigned the fresh cases from serial nos.194 to 218 of Court No.91 (Hon'ble Mr. Justice Gajendra Kumar) and will also take up the fresh cases from serial nos.34 to 66, Applications and remaining determination (except the Additional/Unlisted cases) of Court No.93 (Hon'ble Mr. Justice Arun Kumar Singh Deshwal).
10. Hon'ble Mr. Justice Samit Gopal (Court No.69) in addition to his own determination, will take up the Additional/Unlisted cases from serial nos.3001 to 3100, Applications and remaining determination of Court No.70 (Hon'ble Mr. Justice Sameer Jain).

14. Hon'ble Mr. Justice Gajendra Kumar (Court No.91) in addition to his own remaining determination, will take up the fresh cases from serial nos.1 to 2, Applications and remaining determination (except the Additional/Unlisted cases) of Court No.92 (Hon'ble Mr. Justice Anish Kumar Gupta).
