## THE ALLAHABAD HIGH COURT OFFICERS AND STAFF (CONDITIONS OF SERVICE AND CONDUCT) (AMENDMENT) RULES, 2023

- 1. Short title and commencement.- (1) These Rules may be called "The Allahabad High Court Officers and Staff (Conditions of Service and Conduct) (Amendment) Rules, 2023".
- (2) These Rules shall come into force from the date of publication in the Official Gazette.
- 2. Definition.- In these Rules, unless the context otherwise requires, 'Rules' mean "The Allahabad High Court Officers and Staff (Conditions of Service and Conduct) Rules, 1976".
- 3. Amendment of clause (c) of Rule 24.- Clause (c) of Rule 24 of the Rules shall be amended as follows:

	(c) a person of Indian origin who has migrated from Pakistan, Myanmar, Sri Lanka and East African
Countries of Tanzania (formerly Tanganayika and	country of Tanzania (formerly Tanganayika and Zanzibar) with the intention of permanently settling in India;
