In exercise of the powers conferred by clause (2) of Article 229 of the Constitution of India, Hon'ble the Chief Justice has been pleased to make the following amendments in The Allahabad High Court Officers and Staff (Conditions of Service and Conduct) Rules, 1976:-

THE ALLAHABAD HIGH COURT OFFICERS AND STAFF (CONDITIONS OF SERVICE AND CONDUCT) (AMENDMENT) RULES, 2023

1. Short title and commencement.- (1) These Rules may be called "The Allahabad High Court Officers and Staff (Conditions of Service and Conduct) (Amendment) Rules, 2023".

(2) These Rules shall come into force from the date of publication in the Official Gazette.

2. Definition.- In these Rules, unless the context otherwise requires, 'Rules' mean "The Allahabad High Court Officers and Staff (Conditions of Service and Conduct) Rules, 1976".

3. Amendment of clause (c) of Rule 24.- Clause (c) of Rule 24 of the Rules shall be amended as follows:

EXISTING PROVISION	AMENDMENT
(c) a person of Indian origin who has migrated from Pakistan, Burma, Ceylon and East African Countries of Tanzania (formerly Tanganayika and Zanzibar) with the intention of permanently settling in India;	(c) a person of Indian origin who has migrated from Pakistan, Myanmar, Sri Lanka and East African country of Tanzania (formerly Tanganayika and Zanzibar) with the intention of permanently settling in India;
