5. Hon'ble Mr. Justice Saral Srivastava (Court No.4) in addition to his own determination, will take up the fresh cases from serial nos.109 to 198 of Court No.5 (Hon'ble Mr. Justice Rajeev Misra), on 12.02.2024.
6. Hon'ble Mr. Justice J. J. Munir (Court No.7) in addition to his own determination, will take up the fresh cases from serial nos.101 to 140 of Court No.52 (Hon'ble Mr. Justice Manish Kumar Nigam), on 12.02.2024.
7. The Division Bench presided over by Hon'ble Mr. Justice Rajiv Gupta (Court No.45) in addition to its own determination, will take up the determination (except the Additional/Unlisted cases from serial nos.3052 to 3103) of Court No.67 (The Division Bench presided over by Hon'ble Mr. Justice Rahul Chaturvedi), on 12.02.2024.

9. Hon'ble Mr. Justice Ashutosh Srivastava (Court No.50) in addition to his own determination, will take up the fresh cases from serial nos.141 to 190 of Court No.52 (Hon'ble Mr. Justice Manish Kumar Nigam), on 12.02.2024.
10. Hon'ble Mr. Justice Kshitij Shailendra (Court No.53) in addition to his own determination, will take up the determination of Court No.93 (Hon'ble Mr. Justice Arun Kumar Singh Deshwal), on 12.02.2024.
