**Allahabad High Court (Right To Information) Rules, 2006.**

In partial modification to the earlier Court's Notification No.935/ 2022/ Admin 'G' Dated:Allahabad 08<sup>th</sup> December, 2022, in exercise of powers conferred by Section 5 & 19 of Right To Information Act, 2005 (22 of 2005), the Chief Justice, High Court of Judicature At Allahabad hereby designates the following Officers as Appellate Authority, Central Public Information Officer and Central Assistant Public Information Officer under Section 5 and 19 of Right To Information Act, 2005, with immediate effect.
