In exercise of the powers conferred by clause (2) of Article 229 of the Constitution of India, Hon'ble the Chief Justice has been pleased to make the following amendments in "The Allahabad High Court Private Secretaries (Conditions of Service) Rules, 2001":-

## The Allahabad High Court Private Secretaries (Conditions of Service) (Amendment) Rules, 2024

- 1. Short title and commencement.- (1) These Rules may be called the Allahabad High Court Private Secretaries (Conditions of Service) (Amendment) Rules, 2024.
- (2) These Rules shall come into force from the date of publication in the official Gazette.
- 2. **Definition.-** In these Rules, unless the context otherwise requires, "Rules" mean the Allahabad High Court Private Secretaries (Conditions of Service) Rules, 2001.
- 3. Substitution of Rule 4-B.- Rule 4-B of the Rules shall be substituted as follows: ,

4. Substitution of Rule 4-D.- Rule 4-D of the Rules shall be substituted as follows:
