

ORDER No. 1 / Dt. 02.01.2025

5. Hon'ble Mr. Justice Ajay Bhanot (Court No.5) in addition to his own determination, will take up the fresh cases from serial nos.1 to 85 and the Additional/Unlisted cases from serial nos.3001 to 3060 of Court No.6 (Hon'ble Mr. Justice Neeraj Tiwari).
6. Hon'ble Mr. Justice Piyush Agrawal (Court No.2) in addition to his own determination, will take up the determination (except the fresh cases from serial nos.1 to 85 and the Additional/Unlisted cases from serial nos.3001 to 3060) of Court No.6 (Hon'ble Mr. Justice Neeraj Tiwari).
7. Hon'ble Mr. Justice Vipin Chandra Dixit will sit singly in Court No.73 and will take up the determination of Court No.73 (Hon'ble Mr. Justice Raj Beer Singh).
8. In modification of earlier order dated 21.12.2024, Hon'ble Mr. Justice Manish Kumar Nigam (Court No.34) in addition to his own remaining determination, will take up the fresh cases from serial nos.288 to 337 of Court No.34 , which were earlier transferred to Court No.50 (Hon'ble Mr. Justice Chandra Kumar Rai).
