Hon'ble the Chief Justice has been pleased to grant "Saturdays Leave (SL)" to all the Officers/Officials of the Registry of the Allahabad High Court with following guidelines vide order dated 08.01.2025;

- 1. Only Six (06) "Saturdays Leave (SL)" may be granted to all the officers/officials of the registry from the Calendar year 2025 and onwards.
- 2. "Saturdays Leave (SL)" may be granted to all the officers/officials of the Registry, only on Non-Court working Saturdays other than Second Saturdays.
- 3. "Saturdays Leave (SL)" may be granted and maintained in the same manner as the Casual leave.
- **4.** The Competent Authority for granting the "Saturdays Leave (SL)" may be same as in the case of the Casual leave.
- **5.** Before granting the "Saturdays Leave (SL)" to all the officers/officials working under their supervision, the Supervisory Authority/ Competent Authority must ensure that the work of Hon'ble Court shall not be affected/hampered.
- **6.** "Saturdays Leave (SL)" may not be granted during recess i.e. in the month of June.
- 7. "Saturdays Leave (SL)" may not be combined with the Winter Holidays and Recess.
- 8. No regular leave mentioned in the Financial Handbook, Volume-II (Part 2 to 4) may be combined with the "Saturdays Leave (SL)".
- 9. "Saturdays Leave (SL)" may be combined only with the Casual Leave.
- 10. Only One (01) "Saturdays Leave (SL)" may be granted in a month to an officer/official.
