

ORDER No.3 / Dt. 21.04.2025

1. The Division Bench presided over by Hon'ble Mr. Justice Arindam Sinha (Court No.39) in addition to its own determination, will take up the fresh cases from serial nos.1 to 20 and the Daily Cause List cases from serial nos.44 to 143 of Court No.3 (The Division Bench presided over by Hon'ble Mr. Justice Anjani Kumar Mishra), on 22.04.2025.
2. The Division Bench presided over by Hon'ble Mr. Justice V. K. Birla (Court No.43) in addition to its own determination, will take up the fresh cases from serial nos.103 to 132 of Court No.42 (The Division Bench presided over by Hon'ble Mr. Justice M. C. Tripathi), on 22.04.2025.
3. The Division Bench presided over by Hon'ble Mr. Justice Ashwani Kumar Mishra (Court No.29) in addition to its own determination, will take up the determination (except the fresh cases from serial nos.1 to 20 and the Daily Cause List cases from serial nos.44 to 143) of Court No.3 (The Division Bench presided over by Hon'ble Mr. Justice Anjani Kumar Mishra), on 22.04.2025.

The Division Bench comprising Hon'ble Mr. Justice Siddhartha Varma and Hon'ble Ms. Justice Nand Prabha Shukla will sit in Court No.44 to take up the determination to be taken up there and will also take up the fresh cases from serial nos.133 to 162 of Court No.42 (The Division Bench presided over by Hon'ble Mr. Justice M. C. Tripathi), on 22.04.2025.
5. Hon'ble Mr. Justice Jayant Banerji will sit singly in Court No.3 and will take up the fresh cases from serial nos.63 to 102 and the Daily Cause List cases from serial nos.279 to 338 of Court No.50 (Hon'ble Mr. Justice Chandra Kumar Rai), on 22.04.2025.
6. The Division Bench presided over by Hon'ble Mr. Justice Rajiv Gupta (Court No.46) in addition to its own determination, will take up the fresh cases from serial nos.163 to 192 of Court No.42 (The Division Bench presided over by Hon'ble Mr. Justice M. C. Tripathi), on 22.04.2025.
7. The Division Bench comprising Hon'ble Mr. Justice Siddharth and Hon'ble Mr. Justice Kshitij Shailendra will sit in Court No.47 upto midday recess to take up the determination to be taken up there and will also take up the fresh cases from serial nos.193 to 222 of Court No.42 (The Division Bench presided over by Hon'ble Mr. Justice M. C. Tripathi). Thereafter, Hon'ble Mr. Justice Kshitij Shailendra will sit singly at 2.00 P.M. in Court No.88 and in addition to the cases shown in Court No.85 (Hon'ble Mr. Justice Kshitij Shailendra), will take up the single Bench determination of Court No.88 (Hon'ble Ms. Justice Nand Prabha Shukla), on 22.04.2025.
8. Hon'ble Mr. Justice Syed Qamar Hasan Rizvi (Court No.34) in addition to his own determination, is assigned the fresh cases from serial nos.56 to 105 of Court No.35 (Hon'ble Mr. Justice Manish Kumar Nigam), on 22.04.2025.
