It is hereby notified for general information that Mr. Indradeo Prasad, Advocate, Patna High Court, son of Shri Waleswar Mahto, enrolled as an Advocate by the Bihar State Bar Council, Patna Vide Enrolment No. 315/1998 dated 17.02.1998 is hereby suspended from practicing as an Advocate in the light of order dated 21.05.2025 passed in B.C.I. Complaint No. 01/2025 (The Office of the Advocate General, State of Bihar Vs.
