Priority hearing of old criminal matters for final disposal, Supreme Court Expedited matters, matters pertaining to **Capital Sentence Cases, Habeas Corpus Writs and Anticipatory Bails**, Criminal Cases pertaining to Members of Parliament, Members of Legislative Assembly and Members of Legislative Council and Criminal Appeals upto the year 1990, criminal appeals where the accused has undergone more than half the sentence in view of Section 436A of Cr.P.C. and **Section 479 (1) of Bharatiya Nagarik Suraksha Sanhita, 2023** and the accused is in jail, those cases wherein mediation is successful, matters relating to murder, rape, dacoity and kidnapping, Criminal Revisions filed under Section 102 of the Juvenile Justice Act, 2015.
