NOTIFICATION

It is hereby notified for general information that pursuant to the Order dated 03.07.2025 passed by the Disciplinary Committee of Bar Council of India, Waseem Khan [Enrolment Number D/2140/2018] and Ms. Tarannum [Enrolment Number D/2854/2012] both having Chamber No. 544, Lawyers Chamber Western Wing, Tis Hazari Court., Delhi -110054, found the respondents guilty of serious misconduct and proceed to award punishment of their suspension from the roll Advocates for a period of six (6) months from the roll of the Bar Council of Delhi alongwith compensatory cost of Rs. 20,000/- to be paid to the complainant for mental and physical pain, torture and agony.

As per order dated 03.07.2025, It is made clear if the respondents fail to make the payment of above cost to the complainant within a period of four weeks from the date of receipt of this, order, their suspension from the of Bar Council of Delhi would stand enhanced by another 3 months.

This has emanated from the Bar Council of India Tr. Case No. 1204 2023 titled Md. Mohd. Yaseen Versus Mr. Waseem Khan and Tarannum.
