### **4. SCOPE OF WORK**

#### **4.8 Jammers**

The bidder shall share these details to High Court as and when required.</p> <p>4.8.4 Operating the jammer would be the</p>	<p>"The entire requirement at 4.8 (including 4.8.1 to 4.8.8) is amended and now shall be read as :-</p> <p>The bidder shall cooperate and facilitate to the High Court in procurement and deployment/ installation of lowpowered jammers at each centre to block cellular signals and prevent cheating during examinations. The task shall also include, but not be limited to, providing technical assistance, documentation, safe keeping, and coordination</p>

<p>responsibility of the bidder and the latter would have to ensure the functioning and effectiveness of the equipment. The bidder shall ensure that no tampering is done by any local element at the examination centre.</p> <p>4.8.5 The jammers can be operated by the approved vendors of the Government Agencies/ Department/ PSUs on sub-contract with the bidder.</p> <p>4.8.6 A certificate shall be furnished separately by the bidder and the centre Incharge after completion of each examination that proper accounting has been done for the jammers deployed and none of the jammers are missing.</p> <p>4.8.7 The entire expenditure involved in deployment of jammers shall be borne by the bidder.</p> <p>4.8.8 The bidder shall be solely responsible for safekeeping of the jammers.</p>	with all relevant authorities."
