

## **ORDER No.2 / Dt. 19.01.2026**

1. The Division Bench comprising Hon'ble Mr. Justice Rajesh Singh Chauhan and Hon'ble Mr. Justice Manjive Shukla will sit in Court No.69 and will take up the fresh cases from serial nos.61 to 140 of Court No.45 (The Division Bench presided over by Hon'ble Mr. Justice Rajiv Gupta), on 20.01.2026.

6. Hon'ble Mr. Justice Kshitij Shailendra will sit in Court No.54 and in addition to the cases shown in Court No.28, will take up the determination of Court No.54 (Hon'ble Mr. Justice Dinesh Pathak), on 20.01.2026.
7. Hon'ble Mr. Justice Avnish Saxena (Court No.78) in addition to his own determination, will take up the fresh cases from serial nos.102 to 151 of Court No.81 (Hon'ble Mr. Justice Vivek Kumar Singh), on 20.01.2026.
8. Hon'ble Mr. Justice Rajiv Lochan Shukla (Court No.80) in addition to his own determination, will take up the fresh cases from serial nos.152 to 201 of Court No.81 (Hon'ble Mr. Justice Vivek Kumar Singh), on 20.01.2026.
9. Hon'ble Mr. Justice Chawan Prakash (Court No.84) in addition to his own determination, is assigned the fresh cases from serial nos.94 to 143 of Court No.87 (Hon'ble Mr. Justice Abdul Shahid), on 20.01.2026.
