9. Hon'ble Mrs. Justice Swarupama Chaturvedi will sit singly in Court No.54 and will take up the determination of Court No.54 (Hon'ble Mr. Justice Dinesh Pathak).
10. In modification of earlier order dated 13.02.2026, Hon'ble Mr. Justice Satya Veer Singh will sit singly in Court No.88 and will take up the determination (except the fresh cases from serial nos.268 to 417) of Court No.88 (Hon'ble Mr. Justice Vinod Diwakar).
11. Hon'ble Mr. Justice Lakshmi Kant Shukla will sit singly in Court No.69 and will take up the fresh cases from serial nos.268 to 367 of Court No.88 (Hon'ble Mr. Justice Vinod Diwakar).
