
Thereafter, a further letter dated 16.02.2026 has been received from High Court Bar Association, High Court, Allahabad, essentially doubting the reliability of the list earlier supplied by the High Court Bar Association, High Court, Allahabad through e-mail dated 11.02.2026. Also, a fresh list including names of 9720 members of High Court Bar Association has been supplied with a further request to publish that (new list), separate from the list of members of the Advocates' Association, High Court, Allahabad.

Emerging from the letter dated 16.02.2026 issued by the High Court Bar Association, High Court, Allahabad, the response of the Advocates' Association, High Court, Allahabad, is awaited.

In light of above, the list earlier published on the website of Allahabad High Court on 12.02.2026 is suspended.

Sub. Unsigned/unwhetted tentative list of allottees/members published on the High Court website.

Ref. to above an unsigned/unwhetted list of prospective allottees/members has been published on the High Court website, which has apparent anomalies and incorrect inclusions.

The mixing-up in list of voters of High Court Bar Association with that of Advocate Association appears to be the main reason for errors.

We are forwarding uncontroverted list of members who have participated in the last election of H.C.B.A. since the voter list alone had been asked for vide your letter dated 28.08.2025.

This is the same list which was submitted in response to your letter dated 28.08.2025 on 27.11.2025. Copy of the letter dated 28.08.2025 is enclosed with this letter.

The said voter list along with supplementary voter list published by the Returning Officers is the uncontroverted voter list used in the last election and the same, may be put up on the website for objection. We are also submitting the Voter List arranged in order of seniority from date of membership. Serial Number 1 to 134 of the list are members whose detail of membership is not available but they are enrolled with the Bar Council in between 1962 to 1999.

We request that the list of High Court Bar Association and Advocate Association may be published separately and only thereafter joint list be published from the date of enrolment in the Bar Association.
