

It is hereby notified for general information that the Sub-Committee of the Bar Council of India has, prima facie found **Mr. Deepak Tyagi, Advocate (Enrolment No. D/2370-A/2014)**, R/o Q-28, 3rd Floor, Rajouri Garden, Delhi, guilty of misconduct on the polling day of the election of the Bar Council of Delhi, and vide its order dated 27.02.2026, **Mr. Deepak Tyagi has been placed under interim suspension from practice and from appearing, acting, or participating as an advocate with immediate effect.** The said order shall remain in force subject to immediate consideration by the Disciplinary Committee of Bar Council of India upon first listing. In terms of the aforesaid order, Mr. Deepak Tyagi shall not enter, approach, remain present at, assemble near, or in any manner frequent the counting venue, counting hall, tabulation area, ballot handling zone, result compilation area, or the entry and exit points of the counting premises, nor shall he mobilise any gathering, raise slogans, obstruct access, intimidate any officer, candidate, agent, staff member or supporter, or otherwise interfere, directly or indirectly, with the counting process scheduled from 07.03.2026, Any breach of this direction shall be treated as a further and aggravating act of misconduct.
