

ORDER No.1/ Dt. 06.04.2026

1. The Division Bench comprising Hon'ble Mr. Justice J. J. Munir and Hon'ble Mr. Justice Achal Sachdev will sit in Court No.47 to take up the determination to be taken up there.
2. In modification of earlier order dated 04.04.2026, the Division Bench presided over by Hon'ble Mr. Justice Rajiv Gupta (Court No.48) in addition to its own remaining determination, will take up the fresh cases from serial nos.393 to 492 of Court No.48, which were earlier assigned to Court No.49 (The Division Bench presided over by Hon'ble Mr. Justice Rajeev Misra).

The Division Bench presided over by Hon'ble Mr. Justice Chandra Dhari Singh (Court No.45) in addition to its own determination, will take up determination (except the fresh cases from serial nos.1 to 5 and the Daily Cause List cases from serial nos.6 to 105) of Court No.49 (The Division Bench presided over by Hon'ble Mr. Justice Rajeev Misra).
6. Hon'ble Mr. Justice Prakash Padia (Court No.6) in addition to his own determination, will take up the fresh cases from serial nos.1 to 100 and the Daily Cause List cases from serial nos.178 to 277 of Court No.55 (Hon'ble Mr. Justice Arun Kumar).
7. Hon'ble Mr. Justice Rohit Ranjan Agarwal (Court No.9) in addition to his own determination, will take up the determination of Court No.38 (Hon'ble Mr. Justice Siddharth Nandan).
8. Hon'ble Mr. Justice Dinesh Pathak (Court No.33) in addition to his own determination, will take up the determination (except the fresh cases from serial nos.1 to 100 and the Daily Cause List cases from serial nos.178 to 277) of Court No.55 (Hon'ble Mr. Justice Arun Kumar).
9. Hon'ble Mr. Justice Jai Krishna Upadhyay will sit singly in Court No.80 at 2.30 P.M. till the formation of Regular Division Bench in Court No.42 and will take up the fresh cases from serial nos.291 to 320 of Court No.86 (Hon'ble Mr. Justice Subhash Chandra Sharma).
