Vide Court's letter dated 18-03-2020, it was communicated that the following procedure be adopted for requirement of the books from the library-


- I. The books shall be issued from the library on submission of a written requisition slip duly signed by the Private Secretary or the Bench Secretary attached with Hon'ble Judge in Chamber or Court room, as the case may be.***
- II. The P.S./B.S. concerned shall put their signature with full name and employee code number on every requisition slip of the books required to be issued from the library***

In this regard, I am directed to inform you that 'Book Distribution Management System' (BDMS Software) has been developed by the Computer Centre of this Court towards online requisition of books required to be issued from the library, which has been inaugurated by Hon'ble the Chief Justice in presence of Hon'ble Members of the Library Committee on dated 02-02-2026.

The BDMS Software can be accessed through the link <https://192.168.0.222/libds/login1.jsp>. The User IDs have been created for all the Bench Secretaries of the Court Rooms and the Private Secretaries of the Secretariat of Hon'ble Judges.



The system is proving to be beneficial for smooth day-to-day functioning of the library circulation and office administration.

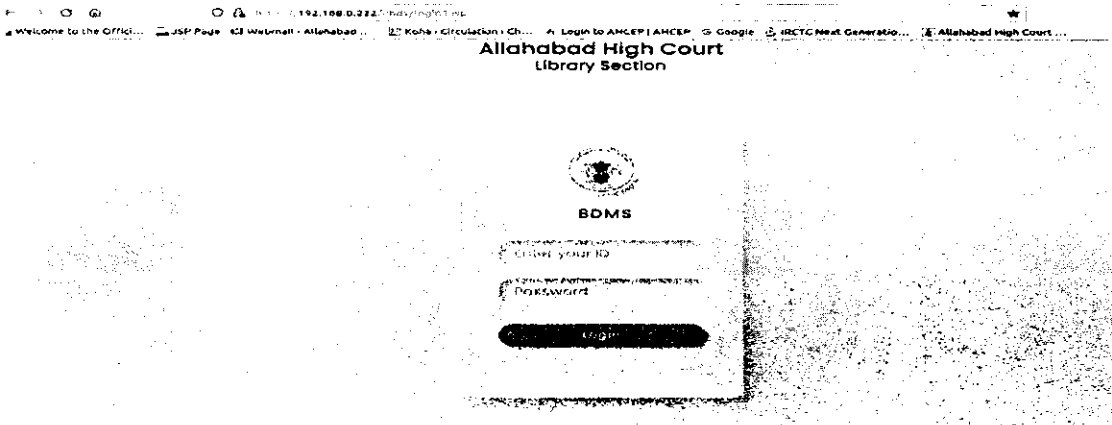

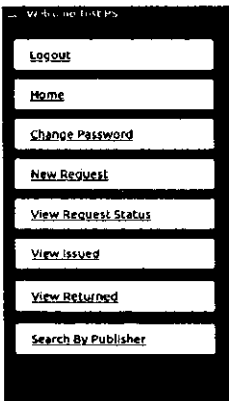
