

ORDER No.1/ Dt. 11.05.2026

1. The Division Bench comprising Hon'ble Mr. Justice M. C. Tripathi and Hon'ble Mr. Justice Siddharth Nandan will sit in Court No.21 to take up the determination to be taken up there.
2. The Division Bench comprising Hon'ble Mr. Justice Rajiv Gupta and Hon'ble Mr. Justice Jai Krishna Upadhyay will sit in Court No.48 to take up the remaining determination to be taken up there.
3. The Division Bench presided over by Hon'ble Mr. Justice Siddharth (Court No.44) in addition to its own determination, will take up the determination of Court No.45 (The Division Bench presided over by Hon'ble Mr. Justice Chandra Dhari Singh).

6. Hon'ble Mr. Justice Anish Kumar Gupta (Court No.34) in addition to his own determination, will take up the determination of Court No.38 (Hon'ble Mr. Justice Siddharth Nandan).
7. In modification of earlier order dated 08.05.2026, Hon'ble Mr. Justice Santosh Rai (Court No.91) in addition to his own determination, will take up the fresh cases from serial nos.1 to 30 and the Daily Cause List cases from serial nos.84 to 183 of Court No.90 (Hon'ble Mr. Justice Raj Beer Singh), which were earlier to be taken up by Hon'be Mr. Justice Jai Krishna Upadhyay (singly).
8. Hon'ble Mrs. Justice Swarupama Chaturvedi will sit singly in Court No.71 at 2.00 P.M. till formation of Regular Division Bench in Court No.3 and will take up the fresh cases from serial nos.150 to 179 of Court No.86 (Hon'ble Mr. Justice Subhash Chandra Sharma).
9. Hon'ble Mr. Justice Kunal Ravi Singh will sit singly in Court No.7 at 2.00 P.M. and will take up the fresh cases from serial nos.98 to 127 of Court No.54 (Hon'ble Mr. Justice Chandra Kumar Rai).
10. Hon'ble Mr. Justice Divesh Chandra Samant will sit singly in Court No.90 at 2.00 P.M. till formation of Regular Division Bench in Court No.46 and will take up the fresh cases from serial nos.208 to 237 of Court No.87 (Hon'ble Mr. Justice Praveen Kumar Giri).

In modification of earlier order dated 08.05.2026, Hon'ble Mrs. Justice Vani Ranjan Agrawal (Court No.93) in addition to her own determination, will take up the determination (except the fresh cases from serial nos.1 to 30 and the Daily Cause List cases from serial nos.84 to 183) of Court No.90 (Hon'ble Mr. Justice Raj Beer Singh), which was earlier to be taken up by Hon'be Mr. Justice Jai Krishna Upadhyay (singly).
