4. In Civil cases and Writ Petitions which require immediate attention, as postulated in 2<sup>nd</sup> part of sub-Rule (1) of Rule 10 of Chapter V of the Rules of the Court, 1952, a separate paragraph showing the urgency be specifically mentioned in the petition itself.
5. Applications regarding urgent hearing of Writ Petitions (excluding Criminal Writs and Habeas Corpus matters, which shall be dealt in Criminal Side) and Cases of Civil nature, during the summer vacation shall be filed before the appropriate Vacation Benches.
6. All left over/passed over fresh Criminal Matters, which could not be taken up prior to the Summer Vacation, will be taken up by the appropriate Vacation Benches during summer Vacation provided that Part Heard and Tied Up matters shall be placed before such Benches, if available.
7. All such Fresh Criminal Matters (including Criminal Writs and Habeas Corpus matters), which could not be taken up prior to the Summer Vacation, will be taken up by the appropriate Vacation Benches during the summer vacation provided that Part Heard and Tied Up matters shall be placed before such Benches, if available.
