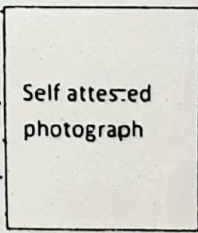


1. **The Member Secretary, UPSLSA or any other officer nominated by the Member Secretary.**

You are further requested to kindly furnish the list of applicants immediately after the expiry of the last date prescribed for submission of applications for the aforesaid post, and in any case not later than July 10, 2026.
