➤ **Number of vacancies:-**

To be decided by Hon'ble Committee on basis of assessment of work.

➤ **Eligibility**

A. For retired Judicial Officers

1. The applicant must have retired as a Judicial Officer from State of Uttar Pradesh.

B. Advocates

1. The applicant must be a practicing Advocate at High Court of Judicature at Allahabad or its Lucknow Bench.

2. The applicant must be enrolled on Advocate Roll of High Court of Judicature at Allahabad or its Lucknow Bench, as the case may be.

C. Law Graduates

1. The applicant must have a degree in Law from a recognised University and should not be engaged in legal practice.

2. The applicant must be permanent resident of Allahabad (Prayagraj)/ Lucknow/Varanasi/ Kanpur (Nagar/Dehat).

3. In case of such Law Graduates, who are in employment, they may submit their applications alongwith 'No Objection Certificate' from their employer. If there is delay in obtaining 'No Objection Certificate', the candidates are advised to apply alongwith receipt of their application for grant of 'No Objection Certificate', but the application must be submitted on or before the last date prescribed in the Notification.

➤ **Age Limit**

1. There shall be no upper age limit.

➤ **Selection**

The inclusion in the panel of Vettors shall be made by the SUVAS Cell, Allahabad with approval of Hon'ble AI Assisted Legal Translation Advisory, e-AHCR and ILR Committee on basis of a test involving translation of two judgments (one civil and one criminal). The inclusion in panel shall always be open to review based on overall performance of the person concerned and the allotment of judgments shall be made by SUVAS Cell as per requirement. The judgments for test shall be sent on email ID of the candidates and they will be required to submit the same as per instructions enclosed therewith. As such, the candidates are requested to have a valid and active email ID for the same.

➤ **Remuneration-**

The remuneration shall be paid @Rs.1/- per word of the English version of the judgment, and in calculating the word-count, all Hindi words as well as details of additional parties & cases (except for the first one) shall be excluded.

➤ **Submission of Applications**

1. Eligible candidates may submit their applications in the attached prescribed format along with self-attested copies of educational qualifications, proof of residence, identity proof, and other relevant documents within the stipulated period, to be submitted by hand / registered post / email est_suvas@allahabadhighcourt.in
