

ORDER No.1/ Dt. 20.07.2026

1. In modification of earlier order dated 18.07.2026, Hon'ble Mr. Justice Saurabh Srivastava (Court No.79) in addition to his own remaining determination, will take up the fresh cases from serial nos.255 to 324 of Court No.79, which were earlier transferred to Court No.77 (Hon'ble Mr. Justice Sanjay Kumar Pachori).
7. In modification of earlier order dated 18.07.2026, Hon'ble Mr. Justice Tarun Saxena will sit singly in Court No.84 and will take up the determination of Court No.84 (Hon'ble Mr. Justice Prashant Mishra-I).

In modification of earlier order dated 18.07.2026, Hon'ble Mr. Justice Lakshmi Kant Shukla (Court No.87) in addition to his own remaining determination, will take up the fresh cases from serial nos.80 to 129 of Court No.87, which were earlier assigned to Court No.85 (Hon'ble Mr. Justice Manoj Bajaj).
9. In modification of earlier order dated 18.07.2026, Hon'ble Mr. Justice Devendra Singh-I (Court No.47) in addition to his own determination, will take up the determination of Court No.85 (Hon'ble Mr. Justice Manoj Bajaj).

In modification of earlier order dated 18.07.2026, Hon'ble Mr. Justice Sanjiv Kumar (Court No.88) in addition to his own remaining determination, will take up the fresh cases from serial nos.102 to 301 of Court No.88, which were earlier transferred to Court No.48 (Hon'ble Mr. Justice Tarun Saxena) and Court No.47 (Hon'ble Mr. Justice Devendra Singh-I).
