The learned Registrar General vide his goodself's order dated 11.08.2026 has been pleased to pass the following directions:

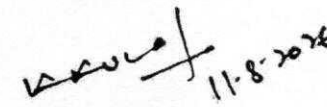
"During a physical inspection undertaken by undersigned on this day, August 11, 2026, at 11:15 AM, it was observed with grave concern that a significant number of vehicles including those belonging to officers/ officials of the Hon'ble Court were parked indiscriminately along the approach road, i.e. the Kanpur Road (Purushottam Das Tandon Marg) under the flyover and service lanes leading to the High Court Parking Building, including the Shambhu Barrack lane.

This unauthorized roadside parking severely restricts traffic flow, creates heavy bottlenecks at the entrance of the Parking Building, restricts emergency access, and causes severe inconvenience to all stake holders.

Accordingly, it is ordered to all officers/officials of the Hon'ble Court to strictly desist from parking any two-wheelers or four-wheelers on the approach roads and service lanes. All such vehicles must be driven directly into the designated Parking Building and parked strictly within the levels and bays demarcated. Any vehicle found parked along the approach roads to the Parking Building and the Shambhu Barrack lane, hereafter shall be impounded / towed at the owner's risk, and the defaulting employee shall face appropriate disciplinary action.

Further, Registrar (Protocol) is directed to co-ordinate with the traffic authorities to further ensure the approach roads, driveways, or service lanes leading to the High Court Parking Building are not utilised for such unauthorised parking, creating unwarranted bottlenecks at the entrance of the Parking Building."

All the Officers/ Officials/ Staff of this Hon'ble Court are hereby asked to ensure strict compliance of the aforementioned order in letter and spirit.
