Applications are invited from the Indian citizens and the candidates of other categories recognized by the Government of India for filling up the following post in the Establishment of High Court, Allahabad under THE ALLAHABAD HIGH COURT OFFICERS AND STAFF (CONDITIONS OF SERVICE AND CONDUCT) RULES, 1976 and orders issued by Hon'ble The Chief Justice from time to time in this regard.

2. ESSENTIAL EDUCATIONAL QUALIFICATIONS & OTHER QUALIFICATIONS:

Minimum Essential Qualification: Bachelor Degree in Physiotherapy from an University approved by U.G.C. Or Recognized by Rehabilitation Council of India/Indian Association of Physiotherapist/ State Medical Faculty having minimum 03 years working experience.

Desirable Qualification: Master of physiotherapy from a University recognized by U.G.C. Or **Recognized** by Rehabilitation Council of India/Indian Association of Physiotherapist/ State Medical Faculty having minimum 03 years working experience in a clinical set up and should be well versed in Electrotherapy and Physiotherapy

3. AGE:

The age limit for the post of O.S.D. (PHYSIOTHERAPIST) as on 01.07.2017 will be as under:-

A candidate for Direct Recruitment on the post of O.S.D. (PHYSIOTHERAPIST) must have attained the minimum age of **21** years and must not have attained the age of more than **35** years on the first day of July of the year in which advertisement is published i.e. **01.07.2017**

4- Nationality – A candidate for recruitment to the above post shall be

- (a) a citizen of India, or
- (b) a subject of Sikkim, or
- (c) a Tibetan refugee who came over to India before 1st January, 1972, with the intention of

permanently settling in India, or

(d) a person of Indian origin who has migrated from Pakistan, Burma, Ceylon and East African Countries of Tanzania (formerly Tanganaykika and Zanzibar) with the intention of permanently settling in India.

Provided that a candidate belonging to category (c) or (d) above must be a person in whose favour a certificate of eligibility has been issued by the State Government:

Provided further that a Candidate belonging to category (c) will also be required to obtain a certificate of eligibility granted by the Deputy Inspector General of Police, Intelligence Branch, Uttar Pradesh.

Provided also that if a candidate belongs to category (d) above, no certificate of eligibility will be issued for a period of more than one year and such a candidate can be retained in service after a period of one year only if he/she has acquired Indian citizenship.

Note: A Candidate in whose case a certificate of eligibility is necessary but the same has neither been issued nor refused, may be admitted to an examination or interview and he/she may also be provisionally appointed subject to the necessary certificate being obtained by him/her or issued in his/her favour.

5. SELECTION PROCEDURE :-

The High Court, Allahabad will hold Interview of the eligible candidates. The information regarding Date, Time and Venue of the Interview shall be intimated to the candidates through admit cards.

6. DATE, TIME AND VENUE OF INTERVIEW:- Date, time and venue of Interview shall be intimated to the candidates through Notice uploaded on the official website in due course of recruitment process as well as through Admit Cards.

7. ADMIT CARD:-

Admit Card shall be sent through Registered/Speed Post on the **address** of the **candidates** mentioned by him in his/her application form.

8. CHARACTER:- The character of a person for direct recruitment to the service must be such as to render him/her suitable in all respect for appointment to the service. It will be the duty of the appointing authority to satisfy himself on this point.

Note- Persons dismissed by the Union Government or by a State Government or by a Local Authority or a Government Corporation owned or controlled by the Central Government or State Government will be deemed to be ineligible for the appointment under these rules.

9. MARITAL STATUS:- A male candidate who has more than one wife living or a female candidate who has married a person already having a wife living shall not be eligible for recruitment to the establishment.

Provided that the Chief Justice may, if satisfied that there are any special grounds for doing so, exempt any person from the operation of this rule.

10. PHYSICAL FITNESS:- No person shall be recruited to the establishment unless he/she be in good mental and bodily health and free from any physical defect, likely to interfere with the efficient performance of his/her official duties. Before a candidate recruited directly is finally approved for

appointment to the establishment and he shall be required to produce a medical certificate of physical fitness.

11. HOW TO APPLY

The application form along with one duly attested copy of High School Mark Sheet, High School Certificate in proof of age/date of birth, Intermediate Mark Sheet, Intermediate Pass Certificates, Bachelor Degree in Physiotherapy from an University approved by U.G.C. Or Recognized by Rehabilitation Council of India/Indian Association of Physiotherapist/ State Medical Faculty, Master of physiotherapy from a University recognized by U.G.C. Or by Rehabilitation Council of India/Indian Association of Physiotherapist/ State Medical Faculty and Certificates and testimonials related to desired experience along with two self addressed envelope (size 5"x10") each bearing postage stamps worth Rs. 40/- should be sent to the Registrar General, High Court of Judicature at Allahabad either by Speed Post, Registered Post with AD or through Courier.

12. GENERAL INSTRUCTIONS:-

- 1.** Candidates should affix a latest coloured photograph taken on or after 1st January, 2017 in passport size duly signed by him and his own signature thereon at the place provided in the application.
- 2.** The envelope containing application should be marked "APPLICATION FOR THE POST OF O.S.D. (PHYSIOTHERAPIST)".
- 3.** Envelope shall contain only one application form. An envelope containing more than one application form, shall stand rejected.
- 4.** Candidates must attach with the application form, certified copies of the certificates in support of their age and educational qualifications and desired experience.
- 5.** Applications may be sent either by Speed Post, Registered Post A.D. Or through Courier.
- 6.** Application will be rejected if photo is not pasted or if certified copy of certificates are not attached with it, or if it is not signed by the applicant or if it is not received by the last date/time.
- 7.** Applications received after last date shall not be entertained and the Court will not be responsible for any postal delay. The defective applications, which are not complete in any respect, will be rejected out-right.
- 8.** The candidates are required to furnish a check list along with application form mentioning therein details (as per format enclosed) about the certificates and the testimonials enclosed with the form.
- 9.** The candidate should mention their own mobile number and valid E-Mail id while submitting their on-line application.
- 10.** Information regarding format of application and other information are available on the website of the Allahabad High Court at www.allahabadhighcourt.in
- 11.** Hon'ble Selection Committee reserves right to modify examination process and fixing the minimum cut off marks without assigning any reasons thereof. Instructions are to be complied with strictly by the candidates.
- 12.** Selection Committee decision shall be final in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, mode of examination process etc.
- 13.** In case it is detected at any stage of recruitment that the candidates don't fulfill the eligibility norms and/or that they have suppressed/twisted or truncated any material facts, their candidature shall stand cancelled without giving any reasons and notice to the candidate.

If any of these shortcomings is detected even after appointment, his/her services shall be liable to be terminated and he/she shall be liable for criminal proceedings.

14. The character of a person for direct recruitment to the service must be such as to render him/her suitable in all respect for appointment to the service. Persons dismissed by the Union Government or by a State Government or by a Local Authority or a Government Corporation owned or controlled by the Central Government or state Government will be deemed to be ineligible for the appointment.

15. No person shall be recruited to the establishment unless he/she is in good mental and bodily health and free from any physical defect likely to interfere with the efficient performance of his official duties. Before a candidate recruited directly is finally approved for appointment to the establishment he shall be required to produce a medical certificate of physical fitness from whom the appointing authority specifies.

16. No recommendation for selection either written or oral other than those required will be taken into consideration. Any attempt on the part of a candidate to enlist support directly or indirectly for his candidature by other means will disqualify him for appointment.

17. The candidates are required to fill in the application form with correct and complete information carefully. If any incomplete or false information is given, then the candidate will be responsible for the same and on the basis of false and incomplete information, the application form shall be rejected at any stage of the selection without giving any reasons/notice. On furnishing any false certificates or indicating wrong category/sub-category regarding caste in the application form or in case of any other default, the High Court, Allahabad shall reject the candidature at any stage of the selection and shall take all necessary action.

18. A Male candidate who has more than one wife living or a female candidate who has married a person having a wife living shall not be eligible for recruitment to the establishment.

19. Information uploaded on the website shall not be provided to the candidate under R.T.I. Act, 2005 read with Allahabad High Court (Right to Information) Rules, 2006. The uploaded information on the website shall be remained for a specific period. Therefore, the candidates are advised to download the uploaded information and keep up with them for future. In due course of recruitment examination, in midway of process neither any application under Right To Information Act, 2005 shall be entertained nor information shall be provided. Factual information under R.T.I., Act shall be provided only after declaration of final result. Reply of inferential (speculative) question shall not be provided.

20. It is to be noted that if a candidate has been allowed to appear in the Interview, it does not imply that the candidate's eligibility has been verified. It does not vest any right with a candidate for appointment. The eligibility shall be finally verified by the concerned Recruiting Agency/Appointing Authority. The candidate should satisfy his/her eligibility before applying and shall be personally responsible in case he/she is not eligible to apply as per the given eligibility criteria on the last date for submission of application form.

21. Furnishing of false, wrong or inaccurate information may lead to cancellation of the test result, forfeiture of the certificate and even prosecution in appropriate cases.

22. Mobile phones, pagers, bluetooth or any other communication devices are not allowed inside the premises where the interview is being conducted. Any infringement of these instructions shall entail disciplinary action including ban from future examinations.

23. Canvassing in any form and use of unfair means during the examinations will disqualify the candidature of the applicant.

24. Selection of the candidates shall be purely on merit base in transparent way. Beware of touts, who promise to get selected candidate on illegal consideration.

13. IMPORTANT INSTRUCTIONS FOR THE CANDIDATES

- 1.** Candidates admission in examination is purely provisional.
- 2.** Candidates appearing in the Interview shall not be entitled for any T.A./ D.A.
- 3.** High Court shall not be responsible for any loss/ injury caused to the candidates in course of appearing in the Interview.
- 4.** Candidate should mention his/her name, father name and Date of Birth in the Application Form as per the High School Examination Certificate or Equivalent Examination Certificate. No subsequent request for its change will be considered or granted.
- 5.** Candidates are required to keep with them at least one identity proof (Photo-Identity Card viz U.I.D., Identity-card issued by College/University, Voter I.D. Card, Driving License, Passport, PAN Card, Bank's Passbook copy with photograph thereon) and shall produce the same on demand at the time of examination at center.
- 6.** The venue, date and time of the Interview along with Roll Number will be intimated through Admit cards.
