### Tender Notice

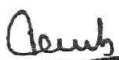
#### for Supply of Liveries and other items for Financial Year 2025-26

Sealed Tenders are invited for the supply of Liveries and other items of various standard and quantity to Allahabad High Court. The detailed terms and conditions pertaining to this tender are as given below.

#### General Terms and Conditions:-

1. Tenders of those suppliers/ firms will be accepted which are registered under GST either with the Government Of India or the Government Of Uttar Pradesh. Copy of Registration Certificate must be Given alongwith the bid.
2. All the participating bidders must submit a copy of the Income Tax Return (ITR) of the two preceding F.Y. years i.e. 2023-24 & 2024-25 along with the bid.
3. Interested firms/ authorized suppliers must specify their Email ID and Whatsapp number for any immediate communications.
4. Interested firms/ authorized suppliers need to deposit a sum of Rs.50,000/- as Earnest Money (EMD) in cash/Demand Draft/Banker's Cheque (in favour of Registrar General, High Court, Allahabad) in the Hon'ble Court by 19/09/2024 2:00 PM.
5. Interested firms/ authorized dealers will have to submit two copies of tender along with the receipt/challan of Earnest Money Deposit as well as the Samples, in a sealed envelope to the Stationery Section of this Hon'ble High Court by 19/09/2024 2:00 PM. Any tender Given after the due date and time will not be considered in any condition.
6. Tenders without Earnest Money Deposit slip and Samples will not be considered.
7. The Successful bidder will be required to submit 10% amount of the order value as a Performance Security as a guarantee for the satisfactory performance of the work under this tender.
8. The participating firms should put the tenders of reputed Brands/Companies, wherever applicable.
9. Specification (such as "Width", "Dimension", "Thread Count", "GSM", "Polyester and Cotton percentage" etc.) of cloth items must be specified in the bids. The bids with mention of 'Thread Count' of the cloths will entail preference.
10. Samples Given should be of minimum 50cmX50cm dimension and in cataloged manner.
11. The successful bidders will have to submit an undertaking mentioning therein to supply the ordered items in a time bound manner which will be fixed by the Hon'ble High Court.
12. Taxes(GST etc.)/ incidental charges if any, payable by the Bidder for the execution of work under this Tender shall be included in the final Bid Price.
13. All the bidding firms will be informed accordingly about opening of tenders.
14. The tenders such received will be opened in the presence of such bidding firms by any nominated Class-I officer of the Hon'ble High Court.
15. The EMD of the non-successful bidders will be refunded upon request after opening of the tenders, whereas, EMD of the successful bidders will be refunded upon request, after completion of the successful delivery.
16. If any bidding firm does not fulfill any of the tender conditions, tender of such firm will not be considered.
17. After scrutiny and examining the proposals as per the cost and quality requirement of the Hon'ble High Court, the Hon'ble High Court may accept the bid which is found to be suitable or reject any or all of the bids, without assigning any reasons thereof. The decision of the Hon'ble High Court in this regard shall be final and binding. High Court reserves the right to negotiate.

18. No interest shall be payable on any kind of deposit retained by Allahabad High Court during the performance of the work under this tender or during the progression of tender process.
19. Payment shall be considered due only after the satisfactory and successful delivery of items under the purview of this Tender. No advance payment will be made. The payment to the Successful Bidder will be done as per the actual supply of items and the rates agreed thereof.
20. The Quantity mentioned in the tender can be reduced or increased any time by this Hon'ble High Court and any such decision of this Hon'ble High Court shall be final.
21. In case of any failures in compliance to the specifications regarding to the quality, the approved supplier/dealer will be charged with penalties as decided by this Hon'ble High Court.
22. In case the approved supplier/firm fails to supply the item within the time stipulated by the High Court or even after receipt of a notice to complete the supply of the said item within 15 days more time, if so given, the tender of the said firm for supply of the said item only may be considered by the committee.
23. The obligation under the tender shall be governed by and interpreted in accordance with the laws of India. All disputes or differences whatsoever arising between the Parties, out of or in relation to the meaning, scope or execution of work or failure to execute the same whether arising during the progress of the contract or after the completion or abandonment thereof or breach thereof, shall be settled amicably. If, however, the Parties are not able to resolve such disputes or differences amicably, the same shall be referred for Arbitration to a sole Arbitrator, the person appointed by Registrar General, High Court of Judicature at Allahabad. In case any Party wants to take the dispute to a Court of Law after the arbitration award as aforesaid, it is expressly agreed that only the Courts in Allahabad shall have the Jurisdiction.

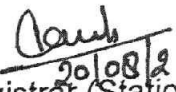
