NOTIFICATION

Pursuant to the Order dated 14.08.2026 passed by the Special Committee of the Bar Council of Delhi under Section 35 of the Advocates Act, 1961, it is hereby notified that **Mr. Vishnu Sharma, Advocate (Enrolment No. D/735/2009)**, has been suspended from practising as an Advocate for a period of **three months** from the date of the said Order. During the period of suspension, Mr. Vishnu Sharma shall not practise as an Advocate or exercise any right or privilege ordinarily available to a member of the Bar. The suspension has been ordered in view of the findings recorded by the Special Committee concerning misconduct relating to manipulation/tampering of ballot papers during the Bar Council of Delhi Elections, 2026. The suspension shall remain in force for a period of three months with effect from 14.08.2026 and shall be subject to review by the Special Committee after two months from the date of the order dated 14.08.2026, or earlier, upon receipt of any report or material relating to the ongoing police investigation in FIR No. 45/2026. This notification is issued for information and necessary compliance by all concerned.
