

NOTICE

Application Form for appointment of Non-official Oath Commissioners-2027 (NOOC-2027) are invited through Online Mode from the practising advocates of High Court of Judicature at Allahabad. Those advocates, who are fulfilling the following norms/criteria fixed by Hon'ble the Chief Justice for appointment of Non-official Oath Commissioners-2027, shall apply for NOOC-2027;

1. All the Advocates having minimum one year of practice and maximum ten years of practice i.e. who have been enrolled in the Bar Council of Uttar Pradesh after 31.12.2016 but before 01.01.2026 shall be included in the list provided that the advocates who have been appointed as Oath Commissioner for three (03) times shall not be included in the list.
2. Advocates who are more than 60 years of age as on 01.01.2027 and enrolled in the Bar Council of Uttar Pradesh before 01.01.2026 shall be included in the list only on the production of age certificate i.e. Matriculation Certificate/Marksheet only.
3. The Advocates who were delisted/debarred by this Hon'ble Court, in the past for any reason shall not be included.
4. The Advocates who are Differently abled (Physically disabled) to the extent of 40% or more duly certified by the Chief Medical Officer/Competent Authority and enrolled in the Bar Council of Uttar Pradesh before 01.01.2026 shall be included in the list on the production of Disability Certificate/Unique Disability ID (UDID).
5. The Advocates against whom F.I.R./complaint has been lodged in the Bar Council of Uttar Pradesh shall not be appointed as Oath Commissioner.
6. The Advocates who have started practising after retirement and receiving pension or received post retiral benefits, shall not be included in the list.
7. Those advocates who do not have 'Advocate Roll Number' or have not applied for the same till last date of submission of online application form shall not be included in the list.
8. The Advocates shall be eligible for swearing of E-affidavit only if they submit their willingness (at the time of filling online application form) for swearing of E-affidavit along-with the declaration that they must possess requisite hardware or ready to procure the same, in the form of computer/laptop and finger print scanner for taking thumb impressions.
9. The lady advocates who are legally divorced and enrolled in the Bar Council of Uttar Pradesh before 01.01.2026 shall be included in the list only on the production of affidavit in support thereof.
10. The advocates shall be eligible to be appointed as Non-official Oath Commissioner only on the production of Advocate Enrolment Certificate/ Certificate of Practice/ Identity Card issued by the Bar Council of Uttar Pradesh.

In this regard, following important instructions are being issued for applying/filling online application form for Non-official Oath Commissioners for the year 2027;

1. The link of Online Application Form for the appointment of Non-official Oath Commissioner-2027 is available on the Official website of Allahabad High Court i.e. <http://www.allahabadhighcourt.in>.
2. The important dates regarding Online Application Form for the Non-official Oath Commissioner-2027 are here as under;

Last date of submission of Online Application Form	: September 30, 2026 till 11.59 P.M.
Last date of Generation of Pdf of Online submitted Application Form	: September 30, 2026 till 11.59 P.M.
Last date of submission of Hardcopy/Printout of Part-A (Application Form)	: October 07, 2026 till office hours

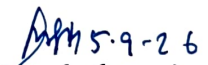
3. The Hardcopy/printout of **Part-A (Application Form)** duly signed by the applicant and verified/forwarded by the concerned Bar i.e. President/Secretary of the High



Court Bar Association Allahabad, Advocates' Association High Court, Allahabad and Oudh Bar Association, Lucknow, for the Advocates who are practising in the High Court at Allahabad and Lucknow Bench, respectively would be submitted in the **Chamber of the Joint Registrar (Admin. E-I), 5th Chamber, 8th Floor, Administrative Annexe Building, High Court, Allahabad** in case of Allahabad and in the office of the **Senior Registrar, High Court Lucknow Bench, Lucknow** in case of Lucknow Bench, Lucknow on working days between 02.00 to 04.00 P.M.

4. If any applicant submits online application form and fails to submit the hardcopy/printout of **Part-A (Application Form)** or submit the same without his Signature (on both the pages) or submit the same without verification i.e. Seal & Signature of the President/Secretary of the concerned Bar will also be considered as incomplete and will be rejected.
5. If the hardcopy/printout of **Part-A (Application Form)** submitted by the applicant or any of the uploaded documents found altered, the candidature of the applicant shall liable to be rejected.
6. Any Application form submitted except online mode (through the link provided on the official website of the Allahabad High Court) for Non-official Oath Commissioner for the year 2027 will not be entertained/accepted.
7. Bar Council Enrolment number & date of enrolment/Disability Certificate number or Unique Disability ID number & date of issuance of Disability Certificate filled in the application form must match with that of the respective uploaded supporting documents. Mismatch in the details with the uploaded supporting documents shall lead to the rejection of the application form.
8. Name of Applicant/Father's name/ Husband's name must match with that of mentioned in the Advocate Enrolment Certificate/Certificate of Practice/ Identity Card issued by the Bar Council of Uttar Pradesh.
9. Hardcopy/printout of online application form i.e. **Part-A (Application Form)** will not be entertained/accepted after last date of submission.
10. If any applicant (having same Enrolment Number) submits hardcopy/printout of two or more application form i.e. **Part-A (Application Form)** bearing different Registration Number, none of the application forms will be entertained and his/her candidature shall be rejected.
11. No modification shall be allowed in the information filled in the online Application Form & in the uploaded documents after final submission of Application Form. Any representation regarding the same shall not be entertained.

**Instructions regarding how to Apply/fill Online Application Form for Non-official
Oath Commissioner-2022**

1. The applicant (who is eligible as per the Notice) may apply through online mode only through the link provided on the official website of the Allahabad High Court i.e. www.allahabadhighcourt.in.
2. The Application form has two (02) stages, In Ist stage the applicant needs to submit their **Personal details, Communication details, Practising detail, Bank detail and Details of Mode of Swearing** through the link provided on the official website. In IInd stage the applicant needs to upload requisite documents.
3. While filling the above-mentioned details in Ist stage applicant must follow the following instructions;
 - (I) The name of Applicant/Father's Name/ Husband's Name must be filled carefully and correctly.
 - (II) The Mobile number and Email Id of the applicant must be valid.
 - (III) The Enrolment Number of Bar Council of Uttar Pradesh must be filled by the applicant in following patterns (as the case may be):
 - (a) UP/XXXXX/YYYY, where 'XXXXX' denotes the five (05) numeric digit Enrolment Number and 'YYYY' denotes the year of Enrolment (eg. If an advocate has Uttar Pradesh Bar Council Registration no. UP01234/21, he/she must fill in the format of UP/01234/2021 in the application form).
 - (b) UP/XXXXXZ/YYYY, where 'XXXXX' denotes the five (05) numeric digit Enrolment Number, 'Z' denotes the alphabet and 'YYYY' denotes the year of Enrolment (eg. If an advocate has Uttar Pradesh Bar Council Registration no. UP01234A/21, he/she must fill in the format of UP/01234A/2021 in the application form).
 - (IV) The Advocate Roll Number must be filled in the pattern of A/ZXXXX/YYYY in case of Allahabad & B/ZXXXX/YYYY in case of Lucknow, where 'Z' denotes the alphabet, 'XXXX' denotes the four (04) numeric digit number of Advocate Roll Number (as 0123) & 'YYYY' denotes the year of allotment of Advocate Roll Number. (eg. If an advocate has Advocate Roll Number A/P0123/2022 for Allahabad or B/P0123/2022 for Lucknow, he/she must fill Advocate Roll Number in the format of A/P0123/2022 for Allahabad and B/P0123/2022 for Lucknow Bench, Lucknow, without skipping any alphabet or number).
 - (V) The applicant must fill their Bank details i.e. Bank Account Number, IFSC Code, Name of the Bank, Branch name & District name carefully.
 - (VD) The applicant opting for Mode of swearing as 'Manual and E-swearing Both' must declare that he/she possess or is ready to procure the requisite hardware in the form of laptop/computer & finger print scanner for taking thumb impressions.
4. By clicking on the 'Preview' button the applicant can see the filled particulars and if applicant finds that any of the filled entries/particulars are incorrect, he/she can correct the same by clicking the 'Back' button. Only after ensuring that the details entered are correct, he/she shall proceed by clicking on the "Submit" button, as no changes in any particulars will be allowed. In case of any ambiguity applicant has to fill the form again.
5. On clicking the Submit button at Step 4, the applicant will receive separate OTPs (One Time Password) on their provided Mobile Number and Email Id both. After entering the correct OTPs the Registration number and Password will be generated and the same will be sent to the applicant on their registered E-mail Id. These shall be preserved for future use.

6. After completing the Ist stage, the applicant may login through the link provided on the official website using Registration Number & Password to complete the IInd stage of application form by filling the required information & uploading the requisite documents.
7. The Candidate has to upload only his/ her own photograph, signature, and certificate(s) (and not of anybody else) in following manner, as the facility for correction will not be given after final submission of application form. Before uploading the documents the applicant must ensure that the document is clear and legible. **Illegible/unclear/blurred uploaded documents shall lead to rejection of application form.**
 - (I) The latest passport size photograph and signature (upto 100Kb in jpg./jpeg.) of the applicant.
 - (II) Copy of the Advocate Enrolment Certificate/Certificate of Practice/ Identity Card issued by the Bar Council of Uttar Pradesh (upto 800Kb in pdf.). **Any other document (except any of the above-said three documents) shall not be accepted.**
 - (III) If the applicant was previously enrolled in any other Bar Council and later on transferred to Bar Council of Uttar Pradesh, he/she must mention the enrolment number & date of enrolment of previous Bar Council in the application form and upload the copy of the Advocate Enrolment Certificate/Certificate of Practice/Identity Card issued by the previous Bar Council (upto 800Kb in pdf.).
 - (IV) Copy of the Identity Card issued by the concerned Bar Association (upto 800Kb in pdf.) i.e. High Court Bar Association, High Court Allahabad/ Advocates' Association, High Court, Allahabad/ Oudh Bar Association, High Court Lucknow Bench, Lucknow whichever is applicable. In case of opting, 'I have Applied for membership' applicant need not to upload any document.
 - (V) Differently Abled (Physically disabled) applicant must upload copy of the Disability Certificate/ Unique Disability Identity Card issued by the Chief Medical Officer / Competent Authority (upto 800Kb in pdf.) certifying that the applicant is Differently Abled (Physically disabled) to the extent of 40% or more. **Any other document (except Disability Certificate/ Unique Disability Identity Card issued by the Competent Authority) shall not be accepted.**
 - (VI) Senior Citizen applicant must upload copy of the Matriculation Certificate/Marksheet (upto 800Kb in pdf.) in support of his/her Date of Birth.
 - (VII) The divorced lady advocates must upload the affidavit in support thereof (upto 800Kb in pdf.).
8. Before Final Submission, the applicant can view the uploaded documents and modify the blurred/illegible/unclear document, if any, by clicking the given button.
9. **No modification will be allowed in the uploaded documents, after the final submission of application form.**
10. By clicking on the 'Preview the application form', a Declaration page will be shown. The Applicant must read the Declaration carefully before submitting the application form by clicking the 'Final Submission' button.
11. After final submission, the complete application form containing the **Part-A (Application Form)** and **Part-B (Declaration Form)** will be generated.
12. The duly signed printout/ hardcopy of **Part-A (Application Form)** containing the verification/ forwarding of the President/ Secretary (with Seal and Signature) of the concerned Bar must be submitted in the Chamber of the Joint Registrar (Admin. E-I), 5th Chamber, 8th Floor, Administrative Annexe Building, High Court, Allahabad (in case of Allahabad) and in the office of the Senior Registrar, High Court, Lucknow Bench, Lucknow (in case of Lucknow Bench, Lucknow).

13. After receiving the hardcopy/ printout of **Part-A (Application Form)** by the chamber of Joint Registrar (Admin. E-I), an Application Id will be generated and simultaneously the same will be sent to the applicant via Email on his/her registered E-mail Id as well as through SMS on the registered Mobile Number.
14. The applicant will be solely responsible for the particulars/details submitted in the application form.
15. No Communication shall be made regarding any discrepancy found in the application form.
16. In case of any query or problem facing while filling online application form for Non-official Oath Commissioner-2027, the applicant may contact in the Chamber of the Joint Registrar (Admin. E-I), 5th Chamber, 8th Floor, Administrative Annexe Building, High Court, Allahabad (in case of Allahabad) and in the office of the Senior Registrar, High Court, Lucknow Bench, Lucknow (in case of Lucknow Bench, Lucknow) during office hours.

I, the above named do hereby solemnly affirm and state as under:

1. That, I am one of the applicants for appointment as an Oath Commissioner in the High Court of Judicature at Allahabad and is applying through the High Court Bar Association/ Advocates' Association, Allahabad, and Awadh Bar Association, Lucknow Bench, Lucknow to which I am a member and a practising Advocate in the High Court at Allahabad/Lucknow.
2. That, I declare that the information furnished in the application for appointment of Non-Official Oath Commissioner are true and correct and nothing is false and nothing material has been concealed therein.
3. That, I also declare that I have read the provisions in order XIX CPC as amended by Allahabad High Court and the Rule contained in Chapter IV of Rules of Court, 1952, Volume-I, the conditions prescribed for the Oath Commissioner and will abide by the same.
4. That, I declare that no F.I.R./Complaint is lodged against me.
5. That, I further declare that in case I am appointed as an Oath Commissioner I will adhere to the following conditions strictly:-
 - a) I shall maintain Oath Commissioner's Register strictly in accordance with the provisions given in the Rule-3 of the Chapter-IV of the Rules of the Court as amended by the order of Hon'ble the Chief Justice dated 10.02.2009 and will do the work of verification of affidavits strictly in accordance with the aforementioned Rule.
 - b) I shall immediately submit the Oath Commissioner's Register to the Section Officer, Cash after the same is filled up or at the end of the term of Oath Commissioner.
 - c) I shall charge only that fee for swearing of Affidavits which is prescribed by Hon'ble the Court and will never give my coupons to any other Oath Commissioner or any body else, failing which, I will be liable to be permanently denied of the right to practice as Oath Commissioner or any other punishment as Hon'ble the Court may deem fit.
 - d) I shall maintain proper accounts of the affidavits sworn before me and the amount realized and I will furnish the figures by the 7th day of the succeeding month to the cashier, and will get my registers accounts/checked by the Section Officer, Cash Section of the Court.
 - e) I shall be liable to be removed from the list of Oath Commissioner and to such actions as Hon'ble the Court may deem fit in case of default of any of the above conditions.
 - f) I shall strictly comply with the guidelines/directions dated 13.02.2025 issued in compliance of the order of Hon'ble the Chief Justice, while discharging my duties as an Oath Commissioner.
 - g) **I hereby declare that I possess the requisite hardware or I am ready to procure the same, in the form of Computer/Laptop and Fingerprint Scanner for taking thumb impression.

I, above named do hereby swear and verify that the contents of paragraph no. 1 to 5 of this declaration are true to my personal knowledge. No part of it is false and nothing material has been concealed herein.
