NOTIFICATION

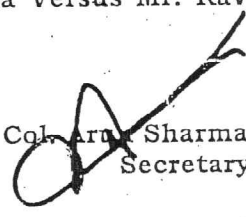
It is hereby notified for general information that, pursuant to the Order dated 08.04.2026 passed by the Disciplinary Committee of the Bar Council of India i.e.

"Therefore, we hold the respondent guilty of misconduct under Section 35 of the Advocates Act, 1961, and his enrolment with the Bar Council is directed to be suspended for a period of eighteen months. The respondent is also burdened with compensatory cost of Rs. 25,000/- to be paid to the complainant, within four weeks of receipts of this order.

In case of failure of the respondent to pay the cost, he will undergo suspension from the roll of the State Bar Council for another six months."

Accordingly, Mr. Ravi Shankar Ravi has failed to pay the compensatory cost as directed, the licence of Mr. Ravi Shankar Ravi, son of Mr. Jib Narayan Das (Enrolment No. D/12/2012), Chamber No. 850, Lawyers' Chambers, Saket Court Complex, Saket, New Delhi - 110017, stands suspended from practice as an Advocate in or before any Court of Law for a period of twenty-four (24) months (comprising the original suspension period of eighteen (18) months and an additional six (6) months), i.e., from 06.08.2026 to 05.08.2028, with effect from the date of this Notification, i.e., 06.08.2026.

This Notification is issued in compliance with the Order passed by the Bar Council of India in BCI Tr. No. 1329/2023, titled "Mr. Abhishek Bhattacharya Versus Mr. Ravi Shankar Ravi."
