Advocates sharing the chamber should be from the same category.

Further, Hon'ble the Chief Justice, vide order dated 03.04.2018, has been pleased to add following conditions / additional guidelines in the approved guidelines for the Chamber Allotment to Learned Advocates and the same shall form part of the affidavit and application form to be submitted by allottee Advocates:

- "1. The allottee-Advocate shall display his / her name plate only on the outer door of the chamber measuring (not more than) 18"X8".
- 2. Display of name plate/board at any other place in the chambers building or the High Court building shall disqualify the allottee-Advocate and his/her allotment shall be cancelled by the Court, forthwith."

The prospective allottees are required to submit their undertaking on affidavit with regard to above two conditions, within the prescribed time as mentioned in this notice, while fulfilling the required formalities.

Affidavit as mentioned above and Demand Drafts are to be submitted at counter number 02 and 03 (Cash Counter) of the Registry Wing of this Court, on all working days from 10.00 a.m. to 2.00 p.m., till 18th April, 2018.
